

4—This exception relates to taking over, putting into repair and maintaining 238 perches of a Canal Bank between the 17th and 18th Locks at Landenstown in Naas No. 1 Rural District. I cannot say if the County Council would be held responsible for any accident that might occur owing to the unfenced condition of any Canal bank converted into a county road.

5—There are however at the present moment several lengths of Canal banks maintained by the County, such, for instance, as at Monasterevan, Milltown (near Athy), Lowlowtown, Littletown, Ballyteigue, Ticknevin, Cloncurry (near Enfield), and nearly the whole length from Landenstown via Digby Bridge and Leinster Aqueduct to Osberstown. I make no reference to streets or independent public roads which are unprotected close to Canals such, for instance, as at Robertstown, Monasterevan, Sallins, Kilcock, etc.

6—The people about Prosperous and adjoining Districts have been agitating for many years to get the length of Canal bank between the 17th and 18th Locks above referred to repaired by the County, but the Canal Company would not consent. The Company also in the past acted on the principle that they were not bound to maintain a Canal bank for public traffic, but only as a towing track for their own horses or for the use of traffic to or from their boats. The Canal Engineer wrote me on 13th August, 1912, saying there would be no objection to this length of bank being repaired by the County so long as the Company's existing rights are reserved. It did not occur to me until now that I should have inquired what the Canal Company's existing rights are, but I am writing to the Engineer for information. I assume the existing rights referred to are those relating to loading and unloading boats and depositing cargo ex boat or for shipment. In addition to this length of Canal bank being the direct route from Prosperous and neighbourhood to Naas it also leads to a graveyard and to Prosperous Chapel and School.

7—At Quarterly Meeting on 6th inst. the Proposal Committee approved of £25 to provide for erecting from time to time Caution Posts supplied by the Automobile Club, and for the supplying and erecting Posts to carry Direction Arms, supplied by the Automobile Association, with names of towns and distances printed on. The £25 is also intended to provide for putting up and taking down Notice Posts before and after Punchestown Races upon roads on which special regulations relating to traffic are in force during the races. At February, 1909, quarterly meeting, £20 was granted for work of this kind, of which £8 2s. 7d. remains unexpended. I recently put up four Caution Posts at Clane, three at Firmount, and two at Castlesize (adjoining turn to Millicent), and I am arranging to have Posts with direction arms put up at Newbridge, Kildare, Maynooth, Kilcullen, Castle-

dermott, Mooretown and Athy—also a direction arm at Naas.

8—Under Statutory Rules and Orders, 1899, Section 27 (2), I request the County Council to authorise the payment of £15 in advance to be made to Contractor for road Registered No. 202—Permanent Index No. 161, Naas No. 1 District. The whole quarter's pay (£28 15s.) was deferred, but I now believe that what I should have done was to certify a payment of £15 for the Contractor, and defer the balance.

9—The Road Board Grant to County Kildare for 1912, if availed of, is £1,045. At last July Quarterly Meetings steam rolling proposals were made by the following District Councils, provided half cost was paid by the Road Board, namely, Athy No. 1 District approved of £972, and Celbridge No. 1 of £2,300. I am also aware that Athy Urban District Council approved of £300. When these proposals were made by the District Councils it was thought that the Road Board would agree to contribute half cost, as was done in 1911, when a grant of £1,200 was given for £2,400 expenditure. The County Council, at August Quarterly Meeting, considered a letter from the Road Board, from which it appeared that the Board would not pay half cost, and hence the County Council had to send back the Proposals for Steam Rolling to the District Councils of Athy No. 1, and Celbridge No. 1 for further consideration.

10—At last quarterly meetings these District Councils rejected the proposals for steam rolling which they approved of at the previous meetings, as the Road Board would not pay half cost. According to the principles laid down by the Road Board, the grant to Athy No. 1 District for an expenditure of £972 would be £292; and to Celbridge No. 1 District for an expenditure of £2,300 the grant would be £730. The estimate for steam rolling in Athy Urban District is £313, and I find that the Road Board grant towards this outlay would be £124. I have written to Athy Urban Council, asking if they will accept the £124.

11—At last Quarterly meeting of Naas No. 1 District, I thought it would be right to bring forward an application which would exactly absorb the whole £1,045 Road Board Grant. To do this I found that the total expenditure should be £3,382. The District Council did not approve of the application.

12—As the County Council is aware, £2,400 is being expended upon Steam Rolling on the Mullingar road, between Leixlip and Maynooth—half cost being contributed by the Road Board. The total length, from one town to the other, is 7,810 lineal yards (that is 1,420 perches, equivalent to 4 miles and 140 perches). The contract for steam rolling is for a length of 6,500 lineal yards (that is 1,182 perches, or 4 miles less 98 perches) thus leaving 238 perches or thereabouts, not includ-

ed in contract,—but this length is for the greater part in tolerably fair order and free from shade of trees, etc. The specified quantity of stone for the 6,500 lineal yards is 6,500 cubic yards, which is an average of one cubic yard to every lineal yard of road. Up to evening of 14th inst. the length of road steam rolled was 6,197 lineal yards (3 miles and 167 perches), and the quantity of stone used was 5,735 cubic yards. The roller is at present working close to Leixlip, where the road is very wide and has a bad shape, and on this account will take a large quantity of material more than the average. But I am hoping that there may be something over 300 cubic yards of stone remaining after the specified length of road, as sanctioned by Road Board, has been completed. In addition to this there will be about 500 cubic yards of stone available out of the supplies provided for ordinary maintenance before steam rolling took place. In the specification, Contractor is bound to allow the sum of £400 to pay for hire of steam roller, drainage work, repairs to defective gulleys, wages of overseer, etc. Any balance of the £400 remaining can be expended in supplying and spreading extra stone in addition to the 6,500 cubic yards specified. It is probable that £100 out of the £400 will be available for extra stone which, at the contract price of 6.15 shillings per cubic yard, supplied and spread, would provide for, say, an additional 325 cubic yards of stone. All available stone remaining after completing the contract will be applied to steam rolling and improving as far as possible the length of 238 perches above referred to, which is not included in the contract. The total amount certified so far for Contractor is £1,429 19s. 8d., which includes £120 paid to County Council for hire of steam roller and £29 11s. 3d. wages paid to overseer.

13—Since the roller was delivered to the County Council by the makers (23rd May, 1911), up to last evening (14th inst.) the roller has earned £325. The total of all expenses certified for wages, coal, oil, and sundries up to this day (15th November) is £287 18s 9d. The cost of 3 tons of coal, and for some fire-kindling wood, paraffin oil, etc. is not included in the £287 18s. 9d., as the bills have not yet reached me. Probably in about three months the steam roller will have no work to do, and I wish to know what I am to do with it. Unless there was some near prospect of work for the roller, the Driver and Flagman could not be kept on. It is not easy to get reliable men to work a roller, and the two I have are satisfactory and keep strictly to regulations, so as to avoid accidents or causes of complaint.

14—As regards the Offices for the Co. Kildare Agricultural Committee, I have not yet given a Certificate for completion to the Contractor. Sundry items, which I pointed out to him, require his attention. Gas has been laid on throughout the building and the furniture provided for will soon be supplied.

The Office for Weight and Measures has been transferred from the old gaol to the new building, but I am informed by the Inspector that a water supply and sink will be required for the purpose of testing. I have taken a note of the matter for next February meeting of Proposal Committee.

15—As regards making of bye-laws under Public Roads (Ireland) Act, 1911, and other Acts I wrote to the County Surveyor of Ayrshire for a copy of the Bye-Laws in his County and he replied that there were no bye-laws relating to traction engines or Traction engine traffic in Ayrshire. I also wrote to the Co. Surveyor of Nottingham and received from him a set of bye-laws which I do not know would be applicable to Ireland generally. There is to be a meeting of Irish County Surveyors on 21st inst. and I have put down for consideration on the agenda the subject of bye-laws.

16—This is not the meeting to report upon River Drainage work, but I think it proper to say that certificates for full payment were given to Contractors in Connell, Foranwell, and Kildare Districts. In Gorteen District the work was set in two sections—full payment is certified for in one section and only £6 out of £17 10s. 0d. in the other section. In this latter case I found that only about one-third of the work was done on 19th September and advantage was not taken of the low water in June. I told Contractor to stop work.

In Baltreacy District the work is divided into 3 divisions. Contractors for two of the divisions have received certificates for full amount of contracts. In the other division £2 13s. 0d. had to be struck off the contract sum of £15 0s. 0d.

As regards Rathangan District the work was done by direct labour under four Overseers—the men were paid weekly which entailed unavoidable expense for inspections and making out of Pay Sheets every week. The weather was unfavourable for this work especially upon the main River. Practically all the rivers and tributaries had good work done upon them except for about 1½ miles of the main river between near Agar Bridge and the Milltown junction. The total expenditure for workmen, overseers and tools is £326 4s. 4d.

The claim for inspections and locomotion expenses by County Surveyor and Assistant Surveyors will be made out and laid before County Council for Rathangan District and for the other river districts.

IRISH COUNTY COUNCILS' GENERAL COUNCIL. COUNTY SCHOLARSHIPS FROM PRIMARY TO INTERMEDIATE SCHOOLS

Report of the Standing Committee on Legislation on the conditions attached to a Draft Scheme for Scholarships tenable at Intermediate Schools by boys and girls from Primary Schools to be held in connection with Scholarships at Irish Universities.

Whilst we believe that Ireland owes a deep debt of gratitude to the Right Hon. Augustine Birrell, P.C., Chief Secretary, for his successful efforts to provide a system of higher education acceptable to the great majority of the Irish people, and whilst we suggest that the thanks of the Council are due to him for his further effort to meet the request of the Council by providing from Imperial Funds a sum of £10,000 per annum for the purpose of founding a system of Scholarships from Primary to Intermediate Schools, the conditions attached to this proposed grant are such that having given to them our most earnest and careful consideration, we are compelled very reluctantly, but unhesitatingly to recommend the Councils to refuse to avail themselves of any grant associated with conditions of this nature, which in our opinion are highly objectionable from many points of view.

In the first place the acceptance of the conditions sought to be imposed would utterly vitiate and render nugatory an important agreement entered into between the Senate of the National University and a deputation from the General Council, whereby the Senate agreed to accede to the request of the deputation that Irish should be an essential subject for matriculation in the University as from 1913, and the Councils represented agreed to strike a rate in aid of University Education and to found Scholarships tenable in the National University, the mandate of the deputation being contained in a resolution adopted with but one dissentient vote at an important meeting of the General Council held on 2nd June, 1909, this resolution being founded upon numerous representations received from the individual Councils forming the association, twenty four of which Councils had bound themselves by resolution to strike no rate save on the above terms.

hearing the views of the Doctors, it was decided to further adjourn the matter until the Tuberculosis Officer takes up his duties permanently.

SCHOLARSHIPS AT INTERMEDIATE SCHOOLS.

The Secretary submitted the following report from the Executive Committee of Irish County Councils' General Council, re Scholarships at Intermediate Schools, which, after having been considered, the Council decided to adjourn the matter until the next Quarterly Meeting, to be held on the 24th February, 1913.

This is clearly an agreement which should not be lightly disregarded or set aside, and it is equally clear that the Councils cannot look to the Senate for its fulfilment unless they on their part are prepared to adhere honourably to their side of the bargain and to resist all inducements to violate it.

To open County Council Scholarships to any University which fails to comply with the vital condition as to essential Irish would manifestly be unfair treatment of the University which has agreed to accept it.

It has been alleged in some quarters that in confining their Scholarships to the National University the Irish County Councils whilst within their strict legal right have acted in a narrow-minded and illiberal spirit. We deny that there is the smallest justification for this contention and we invite reference to facts.

The Irish Universities Act, 1908, gives to the elected representatives of the ratepayers whose money provides the County Scholarships effective representation upon the governing bodies of the Constituent College of the National University and of the National University only. In pursuance of the powers thus conferred the Council will, before the close of the present year, proceed to elect nine members on the Governing body of University College, Dublin, five members of the Governing body of University College, Cork, and six members of the Governing body of University College, Galway.

The ratepayers possess no such safeguard with regard to the wise and prudent expenditure of their money in relation to any other University in Ireland, and in confining their support to the University over which they possess some degree of control the Councils but follow the example set them by many Corporate and other authorities in Great Britain who liberally subsidise Universities

upon the Governing bodies of which they possess representation.

The Act manifestly contemplates assistance from the County Councils supplementary to its parsimonious financial provision for the Universities it creates, and it would be highly inequitable to expect the Guardians of the ratepayers interests to add to this burden by subsidies to already wealthy and highly endowed Institutions.

The constitution of the National University of Ireland has been framed by its authors with the most scrupulous care upon absolutely non-sectarian lines. All possibility of religious preference of any description has been wholly eliminated. The principle of proportional representation has been fully observed in the composition of the Senate and of the professional staff and any objections by an Irish Student winning a County Council Scholarship to pursue his course of studies in this University would be based not upon reason but upon prejudice.

In exercising the power of election conferred by the Charter we strongly urge that the General Council should carefully select the best qualified members of the Council as their representative on the Governing body of University College, Dublin, with a view to retaining in our own hands intimate association with the development and progress of the University.

We regard as educationally unsound the proposal to award to children of tender years upon the results of an examination based chiefly upon personal estimates of their natural intelligence scholarships tenable at Intermediate Schools linked with the extraordinary condition that at the conclusion of a three years course they are to possess, subject only to the veto of their own preceptors, an inalienable right to demand from the Council of their County the provision of £240 of the ratepayers' money to defray the cost of an University Course, subject to no control by the Council in its award or expenditure, subject to no examination to determine whether the original estimate of the child's intelligence has been fully justified or whether the youth's present intelligence and acquirements point to a material advantage to be derived by him from University Education and conditional only upon a mere pass matriculation.

Viewed from a financial standpoint the proposals are equally unsatisfactory. For each £10,000 of free grants the Councils must covenant to provide £20,000 and to hand this sum over for expenditure upon Scholarships allocated upon a flat rate scale vastly more expensive than the County Councils own carefully prepared Scholarship Scheme framed with a view to encourage study in scientific agriculture and other subjects of vital importance to Ireland. In fact it is quite demonstrable that the County Councils could provide from the rate Day

School Scholarships in the Intermediate Schools and County Council Scholarships in the National University at considerably less total cost to the ratepayers than the provision of University Scholarships alone under this Scheme would entail.

In its general aspect the effect of the acceptance of this Scheme would be a relinquishment by the County Councils of the measure of control over University Education placed in their hands by Parliament and its transfer to a body of an unrepresentative character.

We cannot regard with approval any proposal to take the retrograde step of transferring important duties in Ireland from the elected representatives of the people to a nominated irresponsible authority, nor can we recommend the General Council to advise the acceptance of this offer.

The application relating to water supply for Weights and Measures Office may be rejected because I find that in all probability it will be possible to provide for this work out of money in hands owing to a water supply proposed for Agricultural and Horticultural Office not being required. I am assuming that the room intended for this Office will be given to the Insurance Committee which so far as I can form an opinion seems to be an excellent arrangement.

I am applying for £40 to provide for sundry small items of expenditure required from time to time for Courthouses in Athy, Kildare, and Naas. The sum of £40 was granted for this purpose in November, 1911, of which there is at the present moment an unexpended balance of £2 17s. 10d.

I recommend that the Estimate for County-at-Large work during year ending 31st March,

(4) The work of steam rolling upon the Leixlip-Maynooth road towards which the Road Board contributed £1,200, was completed on 24th January, 1913. The steam roller commenced working on the 2nd May, 1912. The total number of hours worked by the roller was 1,875½ which, at 2s an hour, means that the roller earned £187 11s. The cost for a hired roller would have been, I estimate, £286 6s 6d, so that Celbridge No. 1 district benefited to the extent of nearly £100 by having the work done by a county-owned roller.

The specification and estimate sent to the Road Board contemplated supplying and rolling in 6,500 cubic yards of stone upon 6,500 lineal yards of road. All the work (as specified) has been completed, and I have certified accordingly to the Road Board and for the full amount, £2,400. But in addition to completing the 6,500 lineal yards an additional length of 948 lineal yards of road has been coated and rolled, which is accounted for as follows:—I find that the 6,500 lineal yards of road took 6,100 cubic yards of stone, which left 400 cubic yards to do the work upon an additional length of the road. Added to this 400 cubic yards, I was able to utilise 580 cubic yards of material available from the ordinary maintenance contract supply. Owing to saving by using the county steam roller, I asked the contractor to supply 216 cubic yards over and above his contract, which was for 6,500 cubic yards. Thus the whole quantity of stone rolled in was 7,296 cubic yards, and the total length of road coated was 7,448 lineal yards, leaving a length of 260 lineal yards to complete the whole length between Leixlip and Maynooth. At the quarterly meeting in Maynooth on 8th January, I estimated for 250 lineal yards, instead of 260 yards, when the District Council approved of a proposal to complete the work.

(5) I estimate that the cost for all the work done upon this road would have been £2,614 15s 2d if a hired roller had to be employed, and if the 580 cubic yards of stone mentioned had to be procured and paid for as an extra instead of being available from the material provided for maintenance of the road in the ordinary way before the steam rolling was done.

(6) Taking no account of or credit for the £98 15s 6d saving on steam roller hire or for £145, which I put down as value of the 580 cubic yards of extra material, I make out that the nett money to be certified will be £2,371 15s 2d. It is possible that there may be some small error in this sum, but I think it will be found accurate when I am squaring up all outstanding items. The details of the £2,371 15s 2d I put down as follows:—Supplying and spreading 6,500 cubic yards (including for water, sweeping and binding), £2,000; hire of roller to be paid County Council, £187 11s; 216 cubic yards to be paid for extra over the 6,500 cubic yards, £66 8s 4d; overseer's wages, £52 18s 9d; postages (for returns sent daily for 38 weeks, 2 days to contractor and Co.

Surveyor, including 2 account books), £2; repairs to defective gullets and paved channels, £11 17s; 15 grates, 18 inches by 12 inches, and 4 grates, 24 inches by 18 inches, with piping and catch pits as required (including 11 water outlet pipes under footpath), £37 14s 7d; opening gullets and clearing out obstructions in them, including other small items, £13 5s 6d.

(7) The county steam roller was delivered in Naas on 23rd May, 1911. Since that time the effective (or paying) hours worked by it have been 7,231½ hours for District Council, at 2s an hour, and 61½ hours for private persons, at 3s an hour—thus the total earnings of the roller up to the present amount to £370 16s. The total expenses for driver and flagman, coal, oil and sundries have been £339 14s 3d. I have only about two months' work now available for the roller, but I hope the steam rolling approved of in Edenderry No. 2, and Celbridge No. 1 and Athy Urban District, will be pushed forward as quickly as possible to keep the roller from lying idle. These works, however, would provide employment for only about 4 or 5 months. We must, however, hope that at next meetings of District Councils more steam rolling work will be approved of.

(8) Athy No. 1 District Council approved of steam rolling portion of the Castlecomer road, at a cost of £372, on condition that the Road Board agreed to contribute £292. I believe I made a mistake in selecting this length of road, and I now think that owing to the heavy coal traffic upon it a steam rolled surface would not get a fair chance, and injury might thus be done to future prospects of extending steam rolling in the district. I would recommend therefore, that the proposal relating to this work be referred back to the District Council to approve or disapprove as they think fit. But in any case I will make out a recommendation for some other length of trunk road, such as the Athy to Carlow road, or the Athy to Kilkullen road.

(9) Athy Urban District Council approved of £313 to steam roll road between Athy railway bridge and Gallowshill—the Road Board to contribute £124, and the balance (£189) to be paid by the urban district. I wrote to the Road Board asking if they would lend the £189 to the Urban District, and the reply I got was that as it was doubtful whether the County Council can enter into security on behalf of an Urban District Council, and as the Board could not advance money to an Urban District Council direct, the Board were unable to advance any money on loan for the proposed work. After further correspondence with the Road Board, I got a letter dated 12th instant, from the Secretary as follows: "Sir,—In reply to yours of 6th inst., I am directed by the Road Board to say that if the Local Government Board for Ireland are prepared to sanction the borrowing of money by Kildare County Council on the

security of the county rates for works in the Urban District of Athy, the Board will be prepared to advance the sum required (£189) free of interest, repayable in three equal annual instalments."

For the future it would be desirable to ask the Road Board to advance money free of interest for steam rolling upon trunk roads—but to give only 3 years for repayment is a short time.

(10) I applied at Naas No. 1 Quarterly Meeting to steam roll portion (754 perches) of the Naas to Dublin road, commencing at Naas Urban District boundary, the estimated cost being £1,750 towards which the Road Board contribution would be £593—the application was not approved of. Motor lorries (legal speed 12 miles an hour) now regularly travel on this road and on to Newbridge and the Curragh. This kind of traffic is most destructive to macadam road surfaces, even upon steam rolled roads, unless tar is used instead of merely sprinkling water and binding on the

stones before the roller. This long distance (or as it may be called foreign) heavy traffic is a serious matter, and it has added another and a great difficulty to the state of affairs brought about by the ordinary motor car. The road on the whole is as well maintained as it can be, considering that repairs are done in the same way as they were nearly 100 years ago. To strengthen and maintain this road will entail spending money, as is done in the adjoining district of Celbridge No. 2, in Co. Dublin, where the road rate is about 2s 3d in the £—in Naas No. 1 it is just 1s 1d in the £. The 2s 3d rate in Celbridge No. 2 district is called a moderate rate.

(11) The following defaulting contractors, who were reported to the County Council or the Roads Committee, were, with their sureties, processed at recent Quarter Sessions for damages caused by neglect to roads in their charge. The annexed table give particulars and also amounts of decrees—the judge gave two months to have roads repaired in each case:—

(12) The County Council have power to make bye-laws under the provisions of the Public Roads Act, 1911, relating to road locomotives (Traction Engines) used within the county. I reported to the Roads Committee on 1st May, 1912, as follows:—"The Act of 1879 gives power to County Councils to make bye-laws specifying the hours during which locomotives are not to be allowed to pass over roads—the hours must be consecutive and not more than 8 out of the 24, and for regulating the use of such locomotives upon roads and preventing their use upon bridges where the Council is satisfied that such is attended with danger to the public." I have written to several County Surveyors in Ireland and spoken to others, and I find that no bye-laws have been made in any county I enquired about under the Act referred to. The statutory regulations in the various Acts of Parliament are very fully and precise as regards construction and weight of locomotives and their use when either stationary or in motion upon roads and bridges. Therefore on these points no bye-laws would seem necessary. For the present I think bye-laws should

take the shape of registering locomotives same as motor cars, and regulating the amount of annual license to be paid (not exceeding £10). No license is required for any agricultural locomotive, and, of course, this should also apply to any steam roller or locomotive belonging to the County Council. The English Locomotives Act, 1898, Section 9, deals fully with licenses for locomotives, and should be consulted.

(13) A letter was received by the Secretary saying that all around this county, and remarkably so around the Curragh, filthy pools of water lie unfenced and all sorts and conditions of animals have access thereto. The writer of the letter thinks that such pools should be fenced off and cleaned out without delay, and he suggests that a simple, cheap pump be placed in each watering place for watering animals. The writer further states that such pools and public drinking troughs are, to his certain knowledge, a source of infection notably influenza in horses. At last Quarterly Meeting, the County Council referred the matter to County Surveyor. I now beg to report that drinking or watering places

for animals consist either of a running stream or a pool of stagnant water lodging in a hollow alongside margin of a road. My action in the past with respect to these watering places was to widen the road surface adjoining them and form a safe easy slope down towards the water. Sometimes, however, a District Council would not approve of such work, as it would have the effect of lessening the area and storage capacity. Lately I entirely filled up a pool at Mooretown, on Kilcullen to Athy road, as, from the best information I could obtain, it was not required for watering animals. So far as I know, in addition to what has been mentioned, it is the duty of the Co. Council to abate a nuisance on their property if called upon by the Sanitary Authority, and it may be that a stagnant pool on side of road is a nuisance. If this is so the remedy for it would be to drain the stagnant pool so as to allow the water flow off to nearest obtainable outfall and fill up the hollow. I cannot tell if the Road Authority have power to provide and maintain free from contamination drinking places for animals. All sorts and conditions of animals must have access to such places, and unless suitable pumps and troughs be used there must be an entrance and an exit provided if a pool is walled in or around—a cul-de-sac watering place would not answer the purpose. Another thing is that in most cases land should be acquired to provide for building a wall, and the position of the pool should be changed to inside of wall. To put a pump at an existing watering place could not be allowed, because human beings might use it, and the cure would be worse than the disease. Any allowable improvement done to existing watering places could not make them less a source of infection that they are at present—except, perhaps, that any mud in them might be removed and kept removed with advantage. If the County Council have power to provide drinking places for animals free from being suspected as a source of infection, I believe that pumps should be erected in most convenient places with a sufficient and clean water supply including proper troughs.

(14) A proposal will come before the County Council (from Naas No. 1 District) relating to embanking alongside road at Tuckmilltown. Portion of the side of road has fallen into the stream, which flows within a few feet of the road channel, and more is ready to fall. It will be necessary for this work, to alter course of stream, so as to get room for an embankment between it and the road. To do this it will be necessary to encroach upon private land for about 12 perches and to alter level of about 8 perches more. The owner of the field has given his verbal consent to give the 12 perches and allow level of the 8 perches to be altered for the sum of £20. As, however, the land has not yet been legally acquired, the County Council must adjourn the proposal for the present.

(15) As regards the River Drainage Districts of Ballytreacy, Connell, Foranwell, Gurteen, Kildare and Rathangan, I beg to report as follows:—Work upon all these districts was done by contract, except in the case of Rathangan district, which was carried out by direct labour.

Work upon Ballytreacy district last year cost £41 3s 6d—it would have been £43 16s 6d only for £2 13s having to be struck off. No assessment was made last year. The balance in favour of district may be taken at £21. I recommend that £66 13s 4d be raised for coming year.

In Connell district work cost £20, which was certified. The amount raised last year was £33 6s 8d—balance to credit is, say, £29, from which it appears that it will not be necessary to raise any money for 1913.

As regards Foranwell district, certified work cost £49 19s—balance now to credit of district may be taken as £8. Amount raised last year was £60, and I recommend a like sum for coming year.

In Gurteen district amount of contracts was £42 9s, of which £30 19s was certified, and the balance (£11 10s) struck off. Balance to credit may be taken as £23, and the amount of last year's assessment was £50. I recommend that the same sum be raised for coming year.

The amount certified for work in Kildare district was £45. Balance to credit is, say, £12, and the amount raised last year was £50. I recommend the same sum for 1913.

As said, Rathangan river was done by direct labour in four gangs. The total money available for the work was £717 3s 9d, made up as follows:—£600 last year's assessment and £117 3s 9d an unexpended balance handed over to County Council by the old Trustees. The total expenditure for work, tools, and supervision was £360 10s 10d. Should there be no arrears in the £600 collection the balance to credit would be £356 13s 9d, not allowing for Collector's poundage fees. Last year was a most unfavourable one for work upon rivers, and especially in the case of Rathangan district. The combined length of main rivers and tributaries in Rathangan district is 10,384 perches, that is 32 miles and 144 perches, and of this length work was done upon 7,930 perches (24 miles and 250 perches). As said, the cost was £360 10 10d, which gives an average of, say, 11d per perch. I recommend that £300 be the assessment for coming year.

(16) Mr. James Maher has taken down his field fences on both sides of the road (off the main road to Kilcullen) at Oldtown. Each fence was about 60 yards in length. These fences were about 4 feet wide at the base, and about 2½ feet high. For some time past there was a light timber paling along base of fences on road side, which I did not report about, as I thought it was only a temporary one, as it

looked to be. The fences have been entirely removed and his land now extends to the paling—some quicks have also been planted along line of the paling. The travelling surface of the road at this place is 10 feet, and the grass margins measured from road channel to paling are, say, 5 feet and 3 feet respectively. So far as I could see, Mr. Maher evidently intends to extend his land also towards the Kilcullen road by removing another old fence.

(17) I was requested to report upon suitability of a site for a Tuberculosis Dispensary near Kildare, on the French Furze road. I will have a report for the Quarterly Meeting.

(18) I request that the County Council will agree to pay me any out of pocket expenses which I may have to unavoidably incur in connection with plans, etc., for proposed county building at Naas Courthouse and the Tuberculosis Dispensary.

SUPPLEMENTAL REPORTS.

Mr. Chairman, My Lord and Gentlemen,—

On 5th inst. a Committee Meeting was held in connection with a site offered by Mr. Francis Bergin, Kildare, for the proposed Tuberculosis Dispensary. The Committee requested me to report as to the suitability of the site in regard to disposal of the sewage. The site is on the French Furze road between Kildare and the Curragh, and is about 1 mile from Kildare Courthouse, or say $1\frac{1}{2}$ miles from Kildare Railway Station.

On 15th inst. Mr. Bergin came with me to inspect the site. A water main from Kildare town passes in front of it, and I would consider the site a good one were it not that it would be impossible to provide for proper drainage. In this respect the site is very bad, and I, therefore, beg to report that it is entirely unsuitable.

Mr. Bergin has another site which he is willing to sell and which I visited with him. It is on the Stand House road between Kildare Hotel and the Curragh, and about three-quarters of a mile from Kildare Railway Station. It is on the south-east side of road, which means that front of Dispensary cannot face the road—this, however, need not be counted any serious objection. This site can be connected with the town drainage system and the town water supply, and if this is done it would be a suitable site. The piping (6-inch) for drainage would be about 700 yards in length, and the cost would be about £120. The piping (one-inch) for water supply would be about 600 yards, and would cost about £65. These prices contemplate going through private lands. But it would be possible to lay the water pipe along the public road (the length would be about 700 yards this way).

The County Council have no power to lay pipes along private lands, but the Sanitary Authority have power. I would, therefore, recommend this work relating to providing for drainage and water supply to be done by the Sanitary Authority upon such conditions as may be agreed upon.

As regards the water supply the Sanitary Authority might agree to lay a 3-inch water main laid along road passing the site and on towards the Curragh, same as was done on the French Furze road—so far as I can see the levels would not prevent this. But the drain pipe could not be laid along public road as the gradient would be too flat. I believe the Sanitary Authority would be able to get a loan to pay for extending the existing drainage system and water supply to the proposed Dispensary.

There is a house within about 200 yards of the site, but this, I assume, cannot be counted as an objection by anyone.

Mr. Chairman My Lord and Gentlemen,—
The adjourned Quarterly Meeting of Naas No. 1 District was held on 19th instant, when Tenders for six special works and the maintenance of 48 lengths of roads were considered. Omitting a few no tender cases, which I will put down, at the prices allowed, I find that commencing on 1st April next (when the new financial year begins) the cost for ordinary road maintenance will be at the rate of £7,107 14s 10d a year. For special works commencing same time the amount is £122 14s 6d—therefore the new financial year begins with a liability (under these two items) for yearly expenditure upon public works at the rate of £7,230 9s 4d a year. To this sum must be added say, £36 to repay a loan and say, £172, the district's contribution towards main roads in urban districts of Athy and Naas, making in all £7,438 9s 4d. The legal limit of expenditure is £7,765, so that there remains only a balance of £326 10s 8d to provide for special works, sudden damages, and a possible rise in prices when contracts which expire on 1st July next upon 54 lengths of roads have to be renewed.

To meet the demands of modern traffic the main roads should be steam rolled, commencing with the Road Board Trunk roads. But unless the present legal limit of expenditure is increased I am not able to see how this work can be done. The District Council are against increasing the existing legal limit, but the County Council can apply to the Local Government Board to fix a new limit, which, I think, should be £8,500.

I beg to make application for an increase of salary and to point out that at the time of my appointment, it was understood, though not actually stated, that after the lapse of a reasonable time some addition would be made.

In support of my application I beg to state, that since I was appointed, three years ago, work in this office has considerably increased. As you are, no doubt, aware, last year the Council took over a new Drainage District, and decided to maintain it by direct labour, which necessitated the raising of a large rate on this District and the paying of thirty or forty men weekly. The Council have also adopted steam rolling in the county, and there is every likelihood of work still further increasing in this respect. The Local Government Board have recently issued a new order with reference to the claims for irrecoverable arrears of rate in the county, which means the cancelling of all receipts on vacant houses and the issuing of new receipts for the amount payable on land, and owing to the large number of vacant houses in the county this order has considerably increased my work.

SCHEME RE DOMICILIARY TREATMENT FOR PERSONS SUFFERING FROM TUBERCULOSIS.

The Chairman stated that at the last quarterly meeting of the County Council, held on 24th February, 1913, the following members were appointed a deputation to wait on the Local Government Board relative to the question of providing treatment for persons suffering from Tuberculosis, viz.:—Messrs. M. J. Minch, George Wolfe, John Healy, James Sunderland, and Lord Frederick FitzGerald. All the members of the deputation attended at the Local Government Board Offices on Monday, 31st March, 1913, and were accompanied by Dr. Joseph P. Daly, Tuberculosis Officer; Dr. D. P. Coady, Acting Tuberculosis Officer; Dr. Rowan, Hon. Secretary, County Medical Committee; and T. Langan, Secretary to the County Council.

The Chairman further stated that the Local Government Board informed the deputation that it would be necessary for the Council to submit a scheme, together with an estimate of the expenditure in connection with same.

In pursuance of the statement made by the Chairman, the Council proceeded to consider draft scheme submitted by the Secretary, regarding the Home Treatment of persons suffering from Tuberculosis, and after considerable discussion it was proposed by Mr. Joseph O'Connor, seconded by Mr. George Wolfe, and resolved:—"That the following Scheme re Domiciliary Treatment under the Tuberculosis Prevention (Ireland) Act, 1908, be adopted."

The Treatment to be carried out as far as practicable under the care and direction of a Medical Practitioner subject to the following conditions—

(1)—That the Medical Practitioner attend each patient at such intervals as may be determined by the Insurance Committee acting on the advice of the Tuberculosis Officer to be necessary in the interest of the patient, and that an estimate of the cost and probable duration in each case of such treatment be submitted to the Insurance Committee.

(2)—That the Medical Practitioner gives the patient such instructions as are required as to his mode of living, diet, rest and work, and as to the precautions necessary to prevent him re-infecting himself, or infecting other members of the household.

(3)—That the Medical Practitioner keeps a brief record of the clinical history of the illness of each patient, and particulars of the treatment given to the patient, and submit the said clinical history sheet to the Tuberculosis Officer at such times as may be arranged between them.

(4)—That the Medical Practitioner confers with the Tuberculosis Officer or Medical Adviser, at such times and in such circumstances as may be arranged between them in regard to the patients under the care of the Medical Practitioner, who shall report to the Local Sanitary Authority with a view to proper disinfection where necessary.

(5)—That when in the opinion of the Medical Practitioner in attendance, in consultation with the Tuberculosis Officer, it is advisable for a patient to undergo a course of Tuberculin Treatment, the Tuberculosis Officer or the Medical Practitioner shall administer such treatment when practicable.

(6)—That the Tuberculosis Officer shall take charge of all cases requiring after care.

(7)—That cases recommended by the County Insurance Committee be sent to the following Hospitals (at a fee of 3/- per day, or £1 1s. per week), which have been approved by the Local Government Board for treatment of Tuberculosis Disease:—

(1)—Richmond — Surgical Tuberculosis.

(2)—Whitworth — Chronic (advanced) Tuberculosis.

(3)—Hardwicke — Tubercular meningitis and miliary Tuberculosis.

(8)—That the Nursing Staff of the Tuberculosis Dispensary, or the Nurses of any Voluntary Institution with which the County Council may make arrangements (under Clause 5 of Scheme adopted by County Council on 5th July, 1912), shall be available for the care and treatment of all cases undergoing Domiciliary Treatment.

(9)—The following scale of fees shall be paid to the Medical Practitioners as follows:—

1.—Consultation at Surgery, 2/6.

2.—Visit, 2/6.

(10)—An application for Sanatorium Benefit will still continue to be made on Form Med. 1, or similar form which should contain satisfactory evidence that the applicant is an insured person, and be accompanied by a brief statement signed by the Medical Practitioner that the person is, in his opinion, suffering from tuberculosis. On receipt of this application, the Committee may at once recommend the Applicant for Sanatorium Benefit in the form of Domiciliary Treatment, pending further consideration of the case. The Practitioner will immediately assume charge of the case, and will carry out treatment in consultation with the Tuberculosis Medical Officer, in accordance with the order of the Local Government Board indicating the manner of undertaking such treatment. If in the course of such treatment it is made apparent to the Tuberculosis Medical Officer that the case is one in which treatment in a Sanatorium or Hospital or at a Dispensary would be more suitable, it will be his duty to represent the facts to the Committee, who may thereupon make a further recommendation for the necessary treatment to be provided.

(11)—Domiciliary Treatment shall include the provision of Medical attendance and may include in cases where the Tuberculosis Officer, after consultation with the Medical Attendant, considers it necessary for the curative treatment of the patient the provision of Tuberculin and Medicines, also extra nourishing food, additional clothing, additional accommodation and shelters.

That where a Grant is recommended for extra food, &c., it shall be administered under the supervision of the Care Committee or Tuberculosis Nurses as may be arranged.

(12)—That the existing Nursing Associations in the County be requested to act as Care Committees in the different localities in co-operation with the County Council and County Insurance Committee.

(13)—That we request the Boards of Guardians to grant the free use of Dispensaries (situate in the County, when not otherwise required), as branch Tuberculosis Dispensaries.

(14)—That we appoint a Committee consisting of the Members of the County Insurance Committee to carry out the provisions of the foregoing Scheme, when approved by the Local Government Board and Irish Insurance Commissioners.

(15)—Estimate of the probable expenditure under Tuberculosis Prevention (Ireland) Act, 1908, for year ending March 31st, 1914.

RATHANGAN RIVER DRAINAGE DISTRICT.

The following report and estimate from the County Surveyor, relative to maintenance work on Rathangan Drainage District was read and approved:—

Gentlemen.—Last year work upon Rathangan River Drainage District was done by Direct Labour in four Sections. The total expenditure (including £21 18s. 2d. for tools and £34 5s. 8d. for inspections by County and Assistant Surveyors) was £360 10s. 0d. The nett expenditure for work done was therefore £304 6s. 2d.

The combined length of rivers and tributaries is 10,384 perches. Work was done upon 7,930 perches, so that nothing was done to 2,454 perches. Also apart from this it was not possible to thoroughly clear the waterways of the 7,930 perches which it is contemplated should be done during coming year. If the whole 10,384 perches had been done last year in the same way as the 7,930 perches the nett cost would have been probably about £380 instead of £304 6s. 2d. Taking into account the lengths of rivers left undone in each of the four Sections respectively and the more thorough removal of obstructions from bottoms and banks for the entire 10,384 perches I have estimated, as well as I could, what the cost would be for work during coming year upon each of the Sections in accompanying list.

I recommend for coming year that Section 2, Section 3, and Section 4 be done by Contract, and Section 1 by Direct Labour.
