COUNTY SURVEYOR'S REPORT. The County Surveyor's report, as follows, was read :--

Mr. Chairman and Gentlemen,-

I have the honour to report during the Quarter ended 30th June, 1926, the expenditure on ordinary maintenance of roads amounted to £8,707 5s 4d, which I certified to the Finance Committee for Direct Labour.

2—In addition there has been expended during the same period out of Loan for improvement the sum of £279 6s 5d, and on Relief Grants (Works Nos. D. 314 and D. 313) £181 10s 11d, or a total expenditure for Quarter on Maintenance, Loan and Grant Works of £9,168 2s 8d.

3—The works included under the interim Trunk Road Grant of £6,625 are now practically complete except portion of the Naas-Kilcullen road which is about to be commenced. The principal lengths of the roads were dealt with by tar spraying and chipping, but considerable areas comprising all the worst portions were re-surfaced with specially prepared broken stone rolled and bitumen-grouted with our Fowler Wood Roller in a very satisfactory manner.

4-The Government has just an-nounced our share of the first section of the two million pounds grant to be £31,336 and have selected certain portions of the Dublin-Limerick road between Naas and Monasterevan to be As requested by Roads Detreated. partment circular I immediately got into communication with their chief Roads Engineer and gave him my views relating to the matter. The Department apparently have still to settle details governing procedure to be followed, and I am now awaiting further The work is stated to information. consist almost entirely of Bitumen Macadam with a certain amount of I have suggested to cement concrete. Department's Engineer that our Fowler Wood Roller might proceed with grouting, but only whilst the summer weather remains: so this could only be for a small proportion of the work indicated. I am not aware of any Co. Council in the State who can undertake such work with existing plant, and I have accordingly to recommend that the major portion of it be advertised for contracts either for the completed roads or for supply of Bitumen-treated stone ready to roll down on the road. The latter method might have the advantage that our cwn Rollers could be employed (if sanctioned by the Department) and that the preparation of the existing road-widening foundations and proper cambering and drainage could be proceeded with immediately. It seems clear, however, that the first thing to do is to agree upon a definite policy of procedure for the whole of the work since (for example) the amount of money involved in contracts, if any, will have to be ascertained before even a preliminary expenditure on preparatory works to any extent can be sanctioned. I would, therefore, suggest to the Council that time would be probably saved if they were to agree without further postponement on the extent and nature of tenders to be invited from contractors.

5-I have also been in consultation with Chief Roads Engineer regarding plans of proposed alteration of Droichead Nua Liffey Bridge, and am awaiting the Department's decisions.

6—A very large and useful amount of hedge cutting at dangerous corners and even removal of entire fences has been carried out by land-owners during the past six months, and the thanks of the Council are due to those who have done so and to those who have freely given land for road widening by the the Council at similar places. As previously suggested by me the growth of hedges is so rapid that many of those cut down before March are now again obscuring the view. I have given instructions to overseers to trim those again at worst corners and cut off weeds and grasses growing on roadside banks which are themselves sufficient to cause the same nuisance. It will be a good thing when more land-owners recognise that hedge trimming carried out annually, and about the present season or a little earlier, is probably the most economical and certainly the most satisfactory method.

TRUNK ROADS GRANT.

The following report was submitted from Deputation appointed to wait on Mr. Quigley:-

To the Kildare County Council and. Finance Committee.

Mr. Chairman and Gentlemen,-

In accordance with the directions of the ouncil we attended at the County Council Office on the 26th inst and interviewed Mr. Quigley, the Chief Engineer of the (Roads) Department of Local Government and Public Health.

Mr Quigley explained that under the Finance Act, 1926, none of the money available under the £2,000,000 Grant could be used for any but Trunk Roads.

With regard to the expenditure of money on these roads Mr. Quigley intimated that the Council had practically a free hand as his Department were prepared to sanotion any reasonable scheme put forward by the Co. Surveyor.

The question of Contract or Direct Labour was a matter which he was prepared to leave to the Council, but urged the necessity of starting the work with as little delay as possible.

The Committee recommend that the Bitumen Macadam be done by contract and that the drainage and filling of Channels and Fencing, etc., be done by Direct Labour.

Tenders can be taken by giving the work in charge to the County Surveyor with a direction to advertise for Tenders, or by the Council appointing a Tenders Committee and advertising the works.

We recommend the latter course.



COUNTY SURVEYOR'S REPORT.

The County Surveyor's Report as follows was read :

(8727.)

Mr. Chairman and Gentlemen,-I have the honour to report that during the Quarter ended 30th September, 1926, the expenditure on maintenance of ordinary roads amounted to £4,168 12s 1d on main roads and £5,808 2s 1d on County roads. or a total expenditure of £9,975 14s 2d.

In addition, I certified for the six months ending 30th September, 1926, a sum of £6,128 9s 10d for materials, and a sum of £1,082 2s 4d for machinery hire to main roads and, for a like period, a sum of £1,116 7s 1d for materials, and £780 18s 10d for machinery hire to County roads, or a total expenditure of £7,244 16s 11d for materials and £1,863 1s 2d for machinery hire.

There has also been expended (during the Quarter mentioned above) on Government Grant Works the sum of £4,492 15s 9d, and under the National Road Scheme the sum of £355 3s 0d.

I am required by the new regulations to submit now my estimate for road expenditure for the financial year commencing 1st April next. There are in the County some 1,200 miles of public roads to be maintained according to modern ideas. It must be admitted by all that there are probably more conflicting considerations relating to this than to most other estimates. I can only ask for funds to keep our thorough fares at the middling degree of efficiency which will satisfy the average commonsense ratepayers. The present year's road expenditure is equivalent to a flat rate of 2s 8d in the \pounds on the valuation of the County. It will be asked is this a fair burden to place on rateable property at present, and on the other hand is the amount produced sufficient to cope with new traffic conditions satisfactorily. Again, the part road expenditure plays in relieving un-employment, and incidentally relieving or augmenting the taxes specifically raised for such purpose is at present, I find, considered a pertinent matter. The relief citained through motor

fund grants cannot as yet affect our own estimate in this County to any appre-ciable extent. These grants have to be confined to relatively short mileages (on Trunk roads) in carrying out superior or expensive work. Roads rolled in the ordinary way in previous years have to be kept tarred at an expenditure approximating to cost of maintenance before improvement, and this expenditure at present is not

(2) hearly met by grants. We have, of hearly met by grants. We have, of 1,500 miles 30 the National Scheme of 1,500 miles over 70 miles in County Kildare, 30 miles of other Trunk roads and miles of scheduled "main" roads which by no means include all those of heavy traffic and expenditure.

While motor taxes presently avail-able have to be confined to Trunk roads, the effects of motor traffic are too painfully evident on the larger mileage generally, and, I often consider, are more difficult to deal with on many bye-roads where metalling can only be spread loosely and is to such a large extent scattered out of place, and so immediately rendered useless by even the lighter motor cars travelling at Even steam rolling, when high speed. not tarred, will not for long preserve these minor roads from the number of motors now in use As late as 1909 the return of licensed motor vehicles for all Ireland was 3,790 cars and 71 heavy motor waggons; figures to which the numbers in County Kildare alone now nearly approximate; yet at that time the greatest official authority stated that "their use has changed the whole situation and make it necessary to consider the area of charge for at least the leading highways. We have regular passenger bus services in nearly every quarter of the County, and most probably these are not at all represented in As many as 8 our registration list. buses pass in a single hour through one town in the County at a certain time each day. Yet the total revenue derived is for the present at all events inadequate . obviously rates the local and place generally, unless motor taxation is increased, will apparently continue so until the number of motors increase still more and more. This may seem a paradox at first, but is, I think, explained by the fact that it is in practice as costly to construct a road for one or two 'buses (or similar vehicles) in frequent use as for a much greater number. In Eugland where the roads are considered the best in the world the number motors is so great that the huge revenue they produce has met the situation; in Northern Ireland with the number in a smaller proportion to the road-miles, motor taxation is at a higher level, and, reasoning along these lines, a case for a still higher rate of motor taxation in Saorstat Eireann would seem to emerge if other funds are not to be demanded in large amounts, for reconstruction of
