Mr. Kelly being the lowest was eliminated and his three supporters voted for Mr. Robinson, who having 9 votes was declared elected.

Mr. Robinson submitted the names of Messrs Michael Lawler, Mountrice, and Albert Edghill, Quinsboro', as his sureties and the Council approved of same, subject to Mr. Osborne, Solicitor, being satisfied as to their solvency.

COUNTY SURVEYOR'S REPORT.

The County Surveyor's Report as follows was read:—

Mr. Chairman, Miss Darby and Gentlemen,—

I have the honour to report that at the Quaterly Meeting, recently held, Contractors' Applications amounted to £1,047 3s 1d. The manner in which this sum was dealt with is shown in the following table:—

During the Quarter ended 31st March, 1935, in addition to £1,007 9s 11d recommended for payment as above the sum of £11,119 16s 6d was certified to the Finance Committee as follows:—Main Roads, £3,052 6s 3d; County Roads, £1,815 14s 0d; Grants and Loans, £6,251 16s 3d.

After a year's experience of the present road contracts it is evident that the most trouble is caused by the system which allows one person to tender for an unlimited number of roads in the hope of securing a few: and finally being appointed contractor for a larger number than he is genuinely prepared to maintain. Owing to this cause we have had to take up a number of bye-roads after the contractors' neglect being proved, unfortunately, by gradual deterioration of the road throughout some months duration.

A fair amount of road improvement has been kept up during the quarter, financed principally by (a) Road Tax Fund, (b) Relief Grants, (c) Council's own revenue augmented by Loan for restoration of roads in Kill District. Among many others, two road lengths have been treated in a novel manner which may be interesting to the Council; these are between Kildare and Tully and between Sallins and Osberstown, and total about 1 mile in length. The roads were first properly re-formed and re-shaped by having rolled down a liberal quantity of large stone produced by merely quarrying and sledging, but carefully and evenly laid. After a considerable interval during which the traffic showed that these stones were not easy to disturb the road was thoroughly scoured with water and the joints cleaned out and a layer of cement concrete, not more than 2 inches thick, spread and rolled with a light roller. The novelty in this work was the small amount of concrete used and the fact that the traffic was not stopped as it was found to be innocuous to the road probably owing to the fact that the concrete contained a large percentage of 1½" broken stone which prevented the wheels tracking at any stage of the work after the rolling commenced. So far this experiment shows every promise of being successful. The quantity of cement (or "foreign material") used cost only fivepence per square yard, so that a very high labour content was obtained in the work, and the road is, of course, not slippery and will not require tarring.

It will be necessary to consider tenders at your meeting for maintenance of the Kildare and Connell River Drainage Districts. The Rathangan and Greise Districts will be attended by direct labour and you will receive reports of Committees regarding contracts for the remaining Districts to be attended this season.

CONTRACTOR DELANEY.

A letter dated 15th May, 1935, from Mr. Wilkinson, Solicitor, complaining of the way that Contractor Timothy Delaney was being treated and requesting that £17 alleged to be due to him be paid at next meeting.

"In reply to yours of the 15th instant I may mention that Road No. 325 has also been taken from the contractor under Section 54 of the Grand Jury Act, so that he has lost 3 out of the 5 which he originally undertook. This in itself, I fear, is a bad indication of his attention to his work. Contractors are

dealt with on the whole leniently, but I regret being unable to make any alteration in the decisions come to in this case."

Mrs. Delaney, mother of the contractor, attended the meeting and complained of her son not being fairly treated regarding the payment for his contracts.

Having heard the County Surveyor's remarks on the matter the Council was satisfied that the contractor had neglected his contracts. The Council assured Mrs. Delaney that any money properly due under the contracts would be paid.

A Chara,—

With reference to your letter of the 13th ultimo and attached copy of report from County Analyst in respect of the quarter ending 31st March, 1935, I give hereunder particulars of proceedings taken in samples certified as non-genuine:—

(1) New Milk (Two Samples) taken by Garda Kaye, Newbridge. In one case the defendant was convicted and fine and costs to the amount of £2 15s 3d were imposed. In the second case no proceedings were taken

as, when the sample was taken, the trader had no contract with the Army Authorities and was merely obliging on movements of troops at the time, and for this fact as well as the fact that the Food and Drugs Inspector was not charged for the sample taken, the County Council Solicitor held that a prosecution could not be sustained.

(2) New Milk (One Sample) taken by Garda Kaye, Newbridge. No proceedings were instituted in this case as the circumstances under which the sample was taken were similar to case referred to above.

(3) New Milk (One Sample) taken by Guard O'Donnell, Naas. In this case the defendant was convicted and fined 1s and £2 5s 0d costs.

(4) Butter (One Sample) taken by Guard McMahan, Athy. The case against defendant was dismissed on payment of £1 8s 0d as costs.

(5) New Milk (Three Samples) taken by Guard McMahan, Athy. In one of these cases, owing to the adulteration being slight the Analyst did not issue the usual prosecution certificate, and consequently no proceedings will be taken. In the other two cases summonses have been issued for Athy District Court on 14th May, 1935. Result of proceedings will be communicated to you in due course.
