



During the recent storms some 40 to 50 trees fell on direct labour roads and as the road men had to clear the obstructions at a cost of approximatly £9, I am supplying the Secretary with a list of the owners' names, so that applications may be made for refunds.

The following letter, dated Marta 16, 1936, G.45396 36, Cill Dara, from Department of Local Government and Public Health was read :— of the ratepayer in default, i.e., whether ratepayers who are in arrear and in a position to have paid, have been visited personally by the Collector, and warned as to the consequences, (iii) the number of cases in which six days' notices have been issued or legal proceedings instituted. The special reports in all cases should be submitted to this Department.

I am to add that the Minister does not regard the position in any of the Districts in the County as satisfactory, due regard being had to the dates the warrants were issued and the progress made in other counties with comparable economic features Apart from any disciplinary action by way of removal from office, which may be necessary, it should be borne in mind that up to the present considerable deference has been paid to the wishes of the Council in regard to the poundage payable to Collectors who have not complied with the conditions of their appointments. It is obvious that an impression has now arisen that payment at the maximum basis with in many cases an addition by way of bonus, will follow, irrespective of the dates of closing provided application to this effect. is made.

The Minister now deems it necessary that there should be a clear understanding at this stage, that apart from cases in which graver disciplinary action is necessary, poundage at rates which may hitherto have been regarded as customary, will not be sanctioned unless there is reasonable compliance with the conditions prescribed. The Collectors would accordingly do well to realise that the results by way of remuneration will depend on an early closing of their warrants, and that the responsibility for any reductions made from the basic rate of poundage will rest entirely with themselves.

Furthermore, the issue of the warrants for the coming financial year should not be presumed by any Collector who is not prepared to carry out the directions to be issued by the Council in regard to the closing of the current warrant. The Minister sees no reason why a date not later than the 30th proximo should not be fixed by the Council for closing generally in regard to the whole county, and collectors notified to this effect. The views of the Council on this matter will be awaited.

As authorised recently I have consulted with the County Solicitor regarding the constant and extensive use of heavy sand lorries on certain minor roads and the question of proceeding under the Public Roads Act to recover damages which are considerable and increasing. He advises that Counsel's opinion and directions should be obtained, and I have to recommend this course be adopted, as the matter is too important to leave in its present position.

During recent months we have been able to continue road construction and improvement with practically all our steam rolling units and two hired rollers in addition. It is hoped to provide a full programme of this work during the year under the Loan for county roads which the Council decided to apply for some weeks ago and under the Road Fund Grant.

The progress of the reconstruction of Droichead Nua Liffey Bridge continues to be good and I am in hopes that this work will have been completed before your next Quarterly Meeting and public traffic restored.

Arrangements are being made to take tenders at your meeting for contracts for the annual maintenance of the Kildare and also the Ballycowan River Drainage Districts. Direct Labour is being employed on the other districts under maintenance this year.
