A Chara,-"I am directed by the Minister for Local Government and Public Health to refer to the concluding paragraph of this Department's letter of the 14th February last regarding the proposed appointment of Miss Bridget Behan as Clerk on the established staff. The usual method of recruiting Assistant Clerks is to ascertain. by open competitive examination whether the candidate possesses the requisite knowledge and ability for the proper discharge of the duties, and to appoint the candidate who obtains the highest aggregate marks and passes in every subject, provided he or she is within the prescribed limits of age, is free from physical disease and is qualified as to character.

Up to the present the Minister had not been satisfied that such of these conditions as relate to educational qualifications were present in connection with Miss Behan's entry into the Council's service as consideration of the test papers and results showed that neither of the candidates who presented themselves for the examination in 1926 had obtained a standard which would justify a permanent appointment being sanctioned. It has been noted, however, that since then Miss Behan has acquired a satisfactory knowledge of the working of the County Surveyor's Office, and presumably she is now fully qualified to carry out the duties which are appropriate to the permanent post which was advertised in 1926.

The Minister in these circumstances, will be prepared to approve of the appointment now being made permanent, but before this can be done, the regulations applied by the Local Authorities (Office and Employments) Order, 1934, should be complied with. A Chara :--

I am directed by the Minister for Local Government and Public Health to refer to your letter of the 22nd ultimo, relative to the poundage of the Rate Collectors, and to state that he regrets that he cannot see his way to agree with the Council's application for a remission of the penalties imposed, without being furnished with an assurance as to the manner in which the Council themselves will carry out for the future their obligations under the Public Bodies Order in regard to Rate Collection.

It will be recollected that on the 16th March last, a letter was addressed to you drawing attention to the backward state of the collection, and setting out in the clearest terms that no delay beyond the 30th April in closing the warrants could be condoned. As a results reports were obtained from the Collectors and submitted to the Finance Committee, who did not consider the explanations satisfactory, and who directed that all the collectors should be warned that they would not be prepared to recommend any extension of time for closing beyond the 30th April. On the 27th April the Council had before them the Lists of uncollected Rates which they are required by the amended Article 102 (3) of the Public Bodies Order, 1929, to decide on not later than one month after the close of the financial year. Instead of complying with this obligation, the Council adjourned consideration of the cheets until their quarterly meeting and requested the approval of the Minister to the 20th May being fixed for the closing of the collection. The Department's reply indicated that owing to the dilatory manner in which the collection had been proceeded with he was not prepared to sanction the proposal.

I am to point out that the Minister views most seriously this unauthorised departure from the requirements of the Collectors' Bonds, and the Public Bodies Order. The effect has been to encourage belief in the minds of the Collectors that the Minister's views on this important matter may be disregarded, and also to endanger the security afforded to the Council under Fidelity Guarantee and other Bonds. The latter aspect of the matter raises a most serious issue which the Minister considers can only be dealt with by explicit assurances that the prescribed conditions will be adhered to in future. There must be (1) that Collectors will, under penalty of dismissal, be required to furnish their Schedules of uncollected rates not later than one week after the close of each financial year, (2) that the report under Article 102 (2) of the Order will be submitted to the Council within the prescribed

time, and (3) that the lists will be finally dealt with not later than one month after the close of the financial year.

The Minister will be prepared to reopen the question of poundage to the Collectors only in the event of the above assurances being submitted by formal resolution.

Dear Sir,—

I am instructed by Mr. Michael Connoily, of Bluetown, Allenwood, Co. Kildare, to claim from you the sum of £85, damages to his house and chattels at Bluetown, aforesaid, by reason of the County Council's neglect to properly cleanse and scour the rivers and drains under their supervision, as the Rathangan River Drainage Authority, and for your information I enclose an extract of my Engineer's report. Kindly let me hear from you thereon within the next fortnight, as in the event of the Council's refusing to pay compensation, my client will institute proceedings for recovery thereof, at the first available opportunity.

I would also take this opportunity of warning the County Council to carry out their obligations, regarding these rivers and drains in a proper manner, as further flooding is likely to occur, and my client's property is bound to suffer additional damage for which the County Council will be held liable.

EXTRACT.-

Connolly's house was damaged thus: 6" water in kitchen (mid-apartment) and room next road. The water came up through the floor and in through mud walls of which the house is constructed. To-day the floors in kitchen and this room reminded me of the bottom of an excavation recently dug in soft ground. I went to my ankles walking about inside the houseall liquid slime. The ashpit filled with wet mud and the fire place do. The fire is set on a metal disc of some sort laid on stone to elevate it above the ground level to about 4". The floors are all bulges and de-pressions. The foundations (if you can apply such a term to mud walls built on bog) are in a bad way and when the subsoil drys out I am afraid something is going to happen. The bedroom (sough of kitchen) got off

more lightly.

The cart house or barn marked red on map is in the same predicament as the kitchen and dairy. Damage to furniture and bags of provisions, etc., about £10.

In addition to this discomfort, worry and fear caused to the aged couple who reside there, they were also marooned within the house because the flood was all around the house and closed the exit to the road. The discomfort still remains because the floor is in mud and the whole place wet and damp. I estimate a sum of £10, for this.

The house is not very valuable, but it is their home and is now unfit for habitation and is also dangerous. Say £75. Total, £85 0s. 0d.

Dear Sir :--

In reply to your letter of the 2nd instant, any drains in the proximity of Mr. Connolly's house were thoroughly cleaned last Autumn, and, consequently, it is incorrect to assume neglect on the part of the County Council.

We consider that the flooding is due to the condition of a stream which it is not the duty of the County Council to maintain under the Drainage Act, as it was not part of the original works constructed by the Board of Works under the Drainage Act. The private drain in question, into which Mr. Connolly's plot drains, has been partly attended to by the Land Commission, some years ago, and eventually reaches the Rathangan River about $\frac{2}{3}$ of a mile below Mr. Connolly's house.

In conclusion, the Council received no warning from Mr. Connolly that the drains were in any need of attention since they were thoroughly cleaned last Autumn.







COMPLAINT RE CARTAGE.

A special meeting of the Library Commit-tee was held on the 18th instant to examine the Engineer's final report relative to the new County Library building. The Engineer's Assistant, Mr. McDonnell,

attended the meeting and reported that all defects in building were now remedied and that he was quite satisfied with the work of the contractors.

Mr. McDonnell next presented the financial statement as to the entire cost of the building, copy of which is herewith attached. After examining the statement the members of the Committee were surprised to find that the total cost of the building, including Engineer's fees exceeded the combined amount of the Loan, Carnegie Trust Grant and £25 extra voted by the County Council, viz., £4,350 by £280 10s 7d. At all the meetings of the Committee Mr. Sargent, Engineer, gave the members to understand that when all extras and credits had been taken into account the total cost would not exceed the combined amount mentioned above.

The Library Committee are very dissatis-fied with Mr. Sargent for not being more explicit in his statements presented at meetings as, had the members known that the commitments would exceed the money allotted the attention of the Council would have been directed to the matter.

Owing to the limited finances of the Committee the paying of this deficit out of our annual income is impossible and it was decided to request the County Council to assist the Committee to pay this amount, either by way of grant or loan.

UNIVERSITY SCHOLARSHIP SCHEME.

The University Scholarship Scheme, as follows, was approved and copy directed to be sent to each member of the Council :---

The County Council of Kildare offer fc: competition amongst children of parents who have resided within the administrative County of Kildare for a period of at least five years prior to the 1st day of June, 1937, Three Scholarships, value £75 each, tenable for three years at any affiliated College of the National University of Ireland (Non-Catholics may pursue their studies in any University within the Irish Free State). Successful male candidates must attend the prescribed course of lectures for a Degree in Scientific Agriculture or Forestry; successful female candidates may take either a Scientific Agricultural or Forestry or Rural Science course in the approved University. Each application must be accompanied by an Affidavit sworn before a Commissioner for Oaths as to means of parents. In special circumstances on the recommendation of the University Authorities a Scholarship may be extended to a fourth year. Children of parents having a Poor Law Valuation exceeding £150 or an annual income or salary exceeding £350 or upwards, shall not be eligible for Scholar-ships under this Scheme.

1.—Applications for Entrance to County Council Scholarships should be made to the Secretary of the County Council on or before 15th May, and a list of the applications approved by the Council will be forwarded to the Registrar, University College, Dublin, on or before June 1st.

2.—The Examination on which awards of County Council Scholarships may be made will be the Leaving Certificate Examination (Secondary Schools). The candidate must be less than 20 years of age on 1st August, 1937.

3.—Method of Award.—The Scholarships will be awarded in the order of merit in which the candidates stand as to total Honour marks obtained in five subjects at the Leaving Certificate Examination, Full Course or Honours Programme as the case may be. Candidates must obtain Honours in three subjects (one of which must be Irish) and at least a Pass in the remaining two.

In the case of candidates taking one or two Pass subjects, 50 per cent. of the marks so obtained will be counted as Honour marks for the purpose of the total, except in the case of Mathematics, where the percentage will be 331.

4.-The candidates will be placed by the Academic Council of University College, Dublin, in the order of merit according to total marks as above.

5.-Candidates who are not Intermediate students will be allowed to sit for the Leaving Certificate Examination for the purpose of competing for a Scholarship

6.-The attention of all County Council candidates is directed to the requirement of Matriculation in the University as a necessary condition of the holding of a County Council Scholarship in the University, and the subjects presented for the Leaving Certificate Examination should as far as possible include those required for Matriculation. Candidates not passing the Leaving Certificate Examination in the subjects required for Matriculation Examination will be under the necessity of presenting themselves for the Matriculation Examination.

7.-Students must reside in a Collegiate Hostel or other place approved by the Coun-

8.—The cost of the maintenance of each Student—estimated at £46 10s. per annum for a period of 31 weeks (the University Sessions) will be paid direct by the County Council in accordance with Clause 7 to the Owner or Manager of such Hostel.

9.—The fees for the University course of each Student will be paid to the University Authorities from the Secondary Fund. These fees amount approximately to £25 per annum.

10.-The balance of a Scholarship Fund will be paid to the parent or guardian of each Student for the purpose of travelling and incidental expenses.

11.—Applications from Candidates for Scholarships must be accompanied by a certitificate as to character, signed by the applicant's clergyman and head teacher, and some other responsible person to whom the applicant is known.

12.-The Council reserve the right to reject the application of any candidate without reason given.

13.—The award of a Scholarship is limited to such candidates as satisfy the County Council, that they are qualified to profit by University instruction, and are in need of assistance to obtain it. And further, that they continue to satisfy during their University course such tests of ability as may be prescribed by the University.

FORM B.—Certificate from the Principal of the school where the applicant received his or her primary education that the applicant is of unblemished character

applicant is of unblemished character and has, by his or her application and ability, shown himself or herself likely to give a satisfactory return for a secondary education.

to these subjects, and A Candidate who uses Irish instead of English in answering the examination in any subject other than Irish, English and Drawing may obtain excess marks in the subject. In the case of History and Geography, and Rural Science and Nature Study, excess marks not exceed-ing 10 per cent. of the total marks gained in the subject may be scored, and in the case of Arithmetic, Algebra, Geometry and Needlework, excess marks not ex-ceeding 5 per cent. of the total marks stained in the subject may be awarded, provided that in each case the candidate has answered wholly in Irish.


