### SECONDARY SCHOLARSHIPS.

Dear Sir:

We have been consulted by Mr. Patrick Timmons of 24 Saint atrick's Avenue, Athy, with reference to the Award of Scholarships under the Scheme for Scholarships in Secondary and Vocational Schools for the year, 1936.

Our Client is the father of Master Stephen Timmons, who is numbered 4953 in the examination list and who secured ninth place of the nineteen who passed.

We wish on behalf of Mr. Timmons to

make formal objection to the granting of a Scholarship to Master Edward A. Kirwan, who is a pupil of the Athy Christian Brothers, which he entered in August, 1935 Our Client cannot understand by what method of reasoning Master Edward Kirwan, who filled sixteenth place in the list of candidates who passed, is preferred to Master Stephen Timmons, who filled ninth place, notwithstanding that both boys are pupils of the Athy Christian Brothers. If Master Kirwan is entitled to a Scholarship, with much greater force is Master Timmons entitled to it, and as already remarked, both our client and ourselves fail to see the justification for the decision arrived at by the Committee.

These two boys being in the same category our Client relies on paragraph (C) to Rule 4 of the Rules governing the Scheme.

We propose therefore asking the Minister for Education to withold approval of the granting of a Scholarship to Master Edward A. Kirwan, and to enquire into the circumstances under which our client's boy, Master Stephen Timmons, was excluded.

A copy of this letter is being forwarded to the Minister for Education with a covering letter, copy of which is attached hereto.

In the circumstances the committee recommend that the award be cancelled and that Master Stephen Timmons who secured 9th place be given the Scholarship instead of Master Kirwan.

## COUNTY SURVEYOR'S REPORT.

The County Surveyor's Report, as follows, was read :-

Mr. Chairman, Miss Darby and Gentlemen,-

I have the honour to report that at the Quarterly Meeting, recently held, Contractors' Applications amounted to £1,004 2s 4d. The manner in which this sum was dealt with is shown in the following table:-

During the Quarter ended 30th September, 1936, in addition to £823 14s 8d recommended for payment as above the sum of £22,285 18s 6d was certified to the Finance Committee as follows:—Main Roads, £10,792 13s 7d; County Roads, £5,143 2s 0d; Grants and Loans, £6,350

As a result of increased motor traffic it is hardly fair to judge of roads contractors' attention by the condition of their roads; in many cases a few days traffic nullifies work which formerly would last a season. Taking, however, as a definite indication, the measured quantities of road metalling supplied we find that about 10 per cent. of contractors have defaulted and I have had to take over their roads. In some cases contractors themselves have requested to be relieved of their All these contracts will terminate with a triennial period on 31st March next. Any new contracts will be charged with a new stamp duty which has recently been imposed by law, the amount of which will be, for each, ten shillings and a further amount depending upon the amount of the contract. The Council will have accordingly to take this new circumstance into account as well as the other difficulties of road contractors and decide what roads, if any, should be placed under contract for the next three years.

The above is a matter which will affect the Road Estimate for the coming year which, also, has to be decided almost immediately. When the present road contracts were about to be offered three years ago it so happened that the Road Estimate was reduced by 20 per cent. and subsequent tenders still further increased this reduction very considerably with the actual result that the maintenance expenditure for the particular group of roads in question was £2,706 less than the original estimate which was a fairly standard rate. If this amount is now restored it will only mean that the group of 881 miles of "County" roads (those not "Main" roads) partly in contract and partly in direct charge, will have an average annual expenditure at the rate of 1s 4d per perch which is probably insufficient and below the average of the rest of Ireland.

A further increase will be caused by provision for relief of unemployment in the current year in order to co-operate with a Government grant. The amount of the Council's contribution has been fixed at £2,730, and although arising out of probably recurrent circumstances it has been decided to take a loan for three years the cost of which the first year is taken at £1,010.

Even allowing for some reduction of other loan charges these two items alone indicate, for the coming year, a considerably increased road rate. Last year, however, the estimate was reduced from the previous year, the main road group alone losing £6,660. As I mentioned at the time this item effected a saving of only £4,000 to the ratepayers owing to the loss of grant which attaches to main road upkeep. This temporary reduction is now the cause of some difficulty in maintenance, but it enabled some very useful work of improvement by steam rolling to be undertaken which has since been commenced under the loan of £10,000 raised for "County" roads. This, of course, will only suffice for some 12 or 15 miles which is very short of what is required. Early in 1935, I prepared by request, an estimate of necessary road improvement to last over four years to 1939. As a result of long and careful survey of conditions I made a return showing 246 miles of county roads (distinct from main roads) requiring £180,015, of which £49,825 was proposed to be expended in the first year. Since then practically nothing of this has been done. Nothing can be done unless capital sums are definitely provided in some way for the purpose, failing which maintenance expenditure will remain largely uneconomic and complaints will increase from the travelling public who do not understand why one section of road rather than another is left so much below standard. It has taken about 20 years to steam roll about half the roads requiring the same treatment and at some periods progress was very much more rapid than it is at the present, although a far larger number of the community are now responsible for using and damaging the roads by motor traffic.

In connection with the £10,000 loan I would ask the Council to allow some variation of the scheme of improvement as already drafted so as to indicate some other roads which I shall mention at your meeting.

As the Council are probably aware the Liffey Reservoir Bill, 1936, is likely to be soon passed. This will affect this county physically at Poulaphouca, Golden Falls and Glebe East probably in much the same way as the East Leinster Electricity Supply Scheme proposed about which I reported on 21st February, 1924.

E.89599/36. Warble Fly (Treatment of Cattle) Order, 1936.

Sir :-

I am instructed by the Minister for Agriculture to inform you that he has had under consideration the arrangements in force last season for the employment of temporary Inspectors by the Local Authorities for the purposes of the above Order.

From the information before him, including reports furnished by the Departmental Veterinary Inspectors who assisted in supervising the work, it appears that in the case of some of the Local Authorities the allocation of districts among the available staff of temporary Inspectors was not satisfactory. In a number of instances the area could have been more equally divided among the Inspectors. In other cases Inspectors were assigned Districts without due regard being paid to their ordinary places of residence which were either far removed from the centre of their districts or were so situated as to necessitate crossing other Inspectors districts in order to get to their work. The result was that the Inspectors had to traverse the same ground daily, they were required to travel unnecessarily long distances, and they could not in the circumstances be reasonably expected to cover the whole of their districts.

In the circumstances the Minister will be glad if you will go closely into this matter with a view to seeing whether having regard to the experience gained last season, the arrangements in question, in the case of your Local Authority can be improved. In any event you should draw up plans which will ensure that the services of the temporary Inspectors will be utilised to the fullest advantage and that as many stock owners as possible throughout the entire County will be visited during the coming season.

Arrangements are being made for the Departmental Veterinary Inspectors to visit the Clerks to the Local Authorities as soon as possible with a view to discussing with them this and other matters connected with the operation of the Order. I am accordingly to request that you will be so good as to have available for production when one of the Departmental Veterinary Inspectors visit you, as indicated, particulars of the number of temporary Inspectors proposed to be employed by your Local Authority and the districts to be assigned to them.

I beg to report that Curragh Sheep have row received their final dipping for the year, and I am very pleased to say they are all remarkable clean.

In correction with the Dipping of Curragh Sheep, there is a matter I would like to bring to your attention. Owners are notified to have their sheep at Pens at 10 a.m. on day of dipping, several times this year some Flocks have not arrived urtil 12 o'clock and in some cases owners did not arrive until later. This is very urfair to Staff at Ballymary, as they arrive at 8-30 a.m. and dipping is rot firished until late in the evering, and in cases of Spring and Winter Dippings, this is also dargerous for sheep. I would suggest that your Courcil make an Order that any Flocks arriving after 10 a.m. be charged 2 perce per head, and any owner rot attending at same time or sending a representative be charged same rate 2d. per head.

I hope you will not think in asking this I am acting in a vindictive manner to sheep owners. I have tried asking them. I generally have to drive to their places in my car to hurry them up, and it is only 2 Flocks very occasionally a third, that this happers with. The other Flocks are up to time and have plenty of help to deal with their Sheep.

I am sorry for troubling you with this matter, but this last dipping brought it to a climax. I am enclosing list of Owners of one Flock which arrived at 12 p.m. Only one owner was present.

I beg to apply for leave from December 4th to December 12th, inclusive. Mr. Byrne, Athy, will do duty for me.

With reference to your letters of the 13th and 27th ultimo in connection with above, give hereunder particulars of the action taken by the Gardai with regard to the samples which, on analysis, proved defective.

#### New Milk-Received from Gd. McCarthy, Castledermot.

The defective sample was taken from James Doyle. Doyle was prosecuted and aat Castledermot District Court on 9/9/36, the District Justice dismissed the case on the grounds that the percentage of milk solids was not below the percentage required by the Sale of Good and Drugs (Milk) Act, 1935, Section 2. The Aralysts' Certificate showed that the sample was deficient of 18.3% of the mirimum amount of fats which it should cortain.

In accordance with Section 2 of the Food and Drugs (Milk) Act, 1935, milk must be deficient in fats and solids.

New Milk-Received from Garda Darcy, Carbury.

The defective sample was taken from Joseph P. Egan, Derrinturn, Carbury, Co. Proceedings were instituted in Kildare. this case and at Edender y District Court on 8/9/36, the case was asmissed for the same reason as that given in the case of John Doyle. The sample was found to be 36% deficient in fats but was up to the required standards in solids.

New Milk—Received from Garda McMahon, Athy.

This sample was taken from Stephen O'Neill, Athy. The Analyst's certificate showed that the sample was deficient 23.3% of the minimum amount of fats which it should contain. It was up to the required standard in solids, and in view of the decision of the District Justice in the other cases, the Solicitor to the Courty Courcil directed that no proceedings be instituted.

A sum of £3,975 has been provisionally allocated and to this sum must be added the required local contribution of £1,325 towards the cost of carrying out a scheme of road

and footpath works.

Accordingly, if your Council desire to avail of the grant, I am to request the submission, as soon as possible (on the annexed form 11) of a scheme—providing for a gross expenditure of the sum of £5,300 allocated as follows:—

The grant is subject to the condition: (a) that labour shall be recruited through the local Employment Exchange from the lists furnished of those in receipt of Unemployment Assistance, preference being given to suitable applicants in the order in which their names appear on the lists; and (b)

that the unskilled labour shall be rotated.

As this grant is offered primarily with a view to the employment of persons in receipt of Unemployment Assistance it is desired that in submitting a scheme for approval regard will be had to the selection of works which will provide a high content of unskilled labour (exclusive of carters).

In regard to the allocation for Rural Areas (including towns with a population of less than 200) I am to enclose a list of District Electoral Divisions setting out the numbers of Unemployment Assistance recipients not yet provided for under employment schemes. Works should accordingly be planned with reference to these lists. From his local-knowledge or from lists already furnished to him by the Employment Exchanges, the County Surveyor will be able to make any necessary adjustments.

I am to state that the County Surveyor should observe the instructions, previously issued to him, when preparing a scheme for submission except that relating to the "County Factor" which should now be regarded as determining the total estimated cost of the works to be submitted in respect of a particular area and not, as hitherto, the unskilled labour content only.

So far as it may be consistent with the principle that the funds are to be allocated in accordance with the incidence of Unemployment Assistance, it is desired that the works shall be confined to roads of tourist importance.

The annexed forms O.D. 1 and O.D. 2 should be completed and submitted in duplicate with forms 11. Separate form O.D. 1 should be used in respect of each individual work and a summary of the works should be furnished on form O.D. 2.

When submitting the scheme an indication should be given as to how it is proposed to provide the Council's contribution towards the cost of the works.

WARBLE FLY (TREATMENT OF CATTLE) ORDER, 1936.

The following letters were read:-Department of Agriculture, Dublin, 8th December, 1936.

Warble Fly (Treatment of Cattle) Order, 1936.

Sir,-I am directed by the Minister for Agriculture to state, for the information of your Local Authority, that it has been decided to alter the treatment period as defined in Article 3 (1) of the above Order from 15th March-30th June to 1st March-7th July, and that the dressing of infested cattle is to be carried out between the 1st and 7th days of each of the months March, April, May, June The Order will come into effecand July. tive operation on the 1st March, 1937, and the Minister trusts that the Local Authorities will use every effort to ensure that it will be fully enforced during the coming season.

The Minister notes with satisfaction that the requirements of the Order were generally complied with throughout the Saorstat during the 1936 season, and he regards this as being all the more gratifying having regard to the short time available for making arrangements for bringing the Order into opera-

There is one matter, however, which he has observed with some concern, and to which he desires to direct the special atten-

tion of the Local Authorities.

From the reports furnished by the Departmental Veterinary Inspectors who supervised the works it appears that the services of an appreciable number of temporary Inspectors who were employed under the Order

could not be regarded as satisfactory. Some of these Inspectors lacked the necessary qualifications as they seemed to be unable to understand the nature of their duties and had difficulty at the outset in furnishing the required weekly reports. They did not keep any clear or reliable record of the stock-owners visited and cattle examined and treated and they failed to arrange their work properly, with the result that their returns of work were poor and they were unable to cover their respective districts in a systematic manner. Others were reported as showing a lack of activity and zeal in the performance of their duties, and this was evidenced by the negligence they displayed in furnishing the weekly reports of their work, and by the fact that the number of stock-owners which they visited was alto-gether inadequate and seriously below the average number visited by the more efficient Inspectors.

The Minister feels assured that the Local Authorities appreciate that, apart from the necessity for safeguarding the public funds expended on this work and seeing that they are utilised to the greatest possible advantage, the selection of suitable Inspectors is essential in ensuring the successful operation of the Order and the rapid eradication of the warble fly pest. This renders it incumbent on the Local Authorities to make such arrangements in regard to the employment of temporary Inspectors under the Order during the ensuing season as will ensure, as far as practicable, the selection of candidates who possess the requisite qualifications and are likely to discharge their

duties with efficiency.

Having given the matter close consideration, the Minister is of opinion that a valuable means to this end would be the appointment of a Sub-Committee by each Local Authority for the purpose of:-

(a) reviewing the individual records, including the weekly returns of work, of the temporary Inspectors employed during the past season, and advising as to their eligibility for further similar employment; and

(b) considering applications received from new candidates, interviewing such candidates, and reporting as to their

qualifications and general suitability for appointment.

Before being selected each candidate should be required to give an undertaking thath e will devote his whole time to the work and not engage in any other business during his period of employment; that he will procure (if he does not already possess) a means of locomotion that will enable him to carry out his duties; that he will reside at or reasonably convenient to the centre of the district to which he may be assigned; and that he will not hold any agency for the sale on commission of any of the approved cattle wash preparations or engage in any other way, directly or indirectly, in the sale of these preparations.

The Minister will not be prepared to ap-

prove of the re-appointment of temporary Inspectors who failed to justify their employment during the past season, and, in the circumstances, he earnestly recommends the adoption of the procedure above indicated.

The names of the selected candidates and particulars of their proposed districts should be forwarded to this Department not later

than the 31st January next.

I am to request that you will bring this communication before your Local Authority at the earliest opportunity, and inform the Department as to the action taken in the matter.

#### COUNTY SURVEYOR'S REPORT.

The County Surveyor's Report, as follows, was read :-

Mr. Chairman, Miss Darby and Gentlemen,-

I have the honour to report that at the Quarterly Meeting, recently held, Contractors' Applications amounted to £995 5s. 6d. The manner in which this sum was dealt with is shown in the following table: -To strike off under

£54 16s. 6d. £2 10s. 0d. During the Quarter ended 31st December, 1936, in addition to £912 10s. 4d. recommended for payment as above the sum of £13,149 Ss. 6d. was certified to the Finance Committee as follows:—Main Roads, £3527 19s. 3d.; County Roads, £2770 6s. 10d.; Grants and Loans, £6,851

The position regarding roads in contract remains very much the same as mentioned in my 2s. 5d. last report. Contractors appear to have made very little attempt to have the hedge-cutting statute complied with. In a small number of cases I am recommending some extra payment to contractors on the score of very excessve traffic, and I trust the Council will approve. the list of roads to be now advertised for contract the roads causing this difficulty have been

The scheme for the relief of Unemployment began at the commencement of the omitted. quarter under review, and stll pre-occupies all our staff in addition to ordinary duties. The first portion of the fund for the public roads, a sum of £6,810 was allocated to some centres where the greatest number of unemployed resided. Obviously this arrangement, although dealing with the majority, could not reach to many of the unemployed scattered in outlying districts. Accordingly when the second portion, £5300, became available a month ago our suggestion was adopted to make it available throughout all parts of the county and allow the expenditure to run concurrently with the first porton which is not nearly expended as yet. The result is now, as far as I can ascertain, that we have exhausted the entire lists of unemployed for rural areas (and Newbridge) registered at the several local Labour Exchanges, and that no unskilled labourers remain on the dole. (The Urban Councils of Naas and of Athy have separate arrangements for their own centres. The system under which the men are enagaged has been called "rotational" as regards time employed, and we have to see that the number of days allotted to "rotational" as regards time employed, and we have to see that the number of days allotted to "rotational" as regards time employed, and we have to see that the number of days allotted to each man is carefully adhered to. In this connection I think it should be known that there appears to be no objection to men working for other employers on days they are not engaged with us, or even arranging particulars days to work elsewhere if necessary.

In addition to the above funds, grants for Minor Relief Schemes for roads which are not public roads and for development and drainage of turf bogs are also being operated as in the past years. A census we have just taken shows 875 persons sharing in all these Schemes, and as already indicated this does not include those in Naas or Athy. A large amount of useful work is being done, but it seems regrettable that some works of great utility in the more sparsely populated localities cannot be attempted unless the difficulty of bringing men unusual distances from

their homes can be solved. Apart from the above-mentioned schemes, the Council's steam rollers have been kept at work throughout the quarter and a very large tonnage of stone rolled in. Some long lengths. of important secondary roads have been improved at Straffan, Clane, Athy, Burtown, etc., principally by means of the Loan which you took for the purpose. Provision of this kind seems the only way by whch such works can be accomplished apart from the annual grant from the Road Fund which is still absorbed principally by the Trunk roads.

It may shortly be necessary to purchase some new road-making plant, the cost of which, however, could be met to a great extent out of the credit balance of the present machnery ex-

The Finance Committee have made recommendations which I hope will be adopted regrding the filling of the vacancy lamentably caused by the death of Mr. Quinn, Assistant County Sur-

With the approval of the Council I would suggest that notice, as provided under the Conditions of Employment Act, 1936, be given regarding public holidays which fall on working days, substituting for each of these the next following Church Holiday which is not a Sunday.
