

At a largely attended representative meeting of the members of the above Society, held on the 5th inst., Mr. Jas. Lawlor presiding, a Resolution was unanimously passed drawing the attention of your Council to one most important portion of the Maddens-town Lr. tributary river, the cleaning of which is maintained annually by the Co. Council, and to state that 7 or 8 perches approximately of it is a continual source of trouble and hold up to the drainage already done by the Turf Development Board in our bog recently.

There is a sharp or quagmire which runs, as I have said, 7 or 8 perches, and it is suggested that it requires piling with timber in order to make a successful job of removing the trouble, and I am directed to ask your Council's aid in this matter. It is suggested that it would take £200 (two hundred pounds) or so to do this, and it is hoped that you might make some provision for it, as the importance of it cannot be too strongly stressed. Your Engineer, Mr. Rorke, I understand, has a knowledge of this sharp and may be able to say something on the matter. I am to add also that a good number of our members are paying sub-stantial sums yearly towards the maintenance of this river, and until something is done i nthe way of removing the sharp, the other drainage already done will not be of much benefit to our turf producers, and while thanking you in anticipation.

the loan of £10,000 raised for "County" roads. This, of course, will only suffice for some 12 or 15 miles, which is very short of what is required. Early in 1935 I prepared, by request of the Local Government Department, an estimate of necessary road improvement to last over four years to 1939. As a result of long and careful survey of conditions I made a return showing 246 miles of county roads (distinct from main roads) requiring £180,015, of which £49,825 was proposed to be expended in the first year. Since then practically nothing of this has been done. Nothing can be done unless capital sums are definitely provided in some way for the purpose, failing which maintenance expenditure will remain largely uneconomic and complaints will increase from the travelling public who do not understand why one section of road rather than another is left so much below standard. It has taken about 20 years to steam roll about half the roads requiring the same treatment, and at some periods progress was very much more rapid than it is at the present, although a far larger number of the community are now responsible for using and damaging the roads by motor traffic."

The reduction referred to was made at my own suggestion, and there appears to be now no alternative to making a still further reduction in expenditure on "Main" roads, so as to provide some very small steam rolling on "county" roads, and my provisional estimate shortly to be laid before you will indicate something in this direction.

The 15 miles referred to were steamrolled, and immediately afterwards I had to report that 30 miles more were referred to me by different Councillors and others for similar treatment. This, of course, we have been quite unable to undertake, and furthermore, of the 500 miles of unimproved roads in my own charge (not including those in contract) it would not seem unreasonable to suggest that 100 should be improved immediately : Keeping in view the present universality of the motor car, and the fact that the great majority of tax paying motorists probably reside on unimproved roads.

One has only to look down any town or village street to see that the horse-drawn means of transport has already been almost completely superseded, even by the local residents—a fact often predicted, but realised perhaps sooner than expected, and much in advance of adequate preparation or provision.

To motorists it can only be said here that the administration of the funds they provide is not in the hands of the County Council.

The amount allocated to the Council by way of grant from the Employment Schemes Vote for the current financial year is £5,200, subject to a local contribution of £1,833; total, £7,033. I expect this grant is determined by the number of those signing the Register of Unemployment.

The Department of Local Government have drawn attention to the need of more general Hedge Cutting. During recent years perhaps considerable leniency has been exercised in this matter, but Land Owners will understand that it is the duty of the Council to enforce the Law in the matter, and, accordingly, I am instructing Assistant Surveyors to make a special effort to deal with all bad cases in the Season now immediately ensuing.





ROAD GRANT.

With reference to letter from Local Government (Roads) Department, dated 18adh Samhain, 1938 (RGM.-13), consideration of which has been adjourned from last meeting, ite was proposed by Mr. Barton, seconded by Mr. Smyth, and resolved :—

"The Council having learned with regret the decision of the Minister for Local Government and Public Health, indicating that their application for Gran'ts-in-Aid of Secondary Roads may not be acceded to, declare that, notwithstanding, they are still of the decided opinion that it is no longer possible under the existing system of allocation of the

Road Fund (viz., 40 per cent. of Main Road Expenditure) for them to administer to the best advantage the Public Funds of the County that become available for Road Works. Either an inflated amount has to be expended on less urgent Main Road Work while adjacent County roads go from bad to worse; or a greatly increased burden is thrown on the Ratepayers for the same amount of work done.

"They desire to point out the unusual position in Kildare where practically all the roads declared to be Main Roads have already been improved; that such roads form only a small portion (24 per cent.) of the total mileage, whereas many others are bearing traffic of an arterial nature, owing in some part to the proximity to Dublin, comprised of heavy goods and even regular Passenger bus services; and that the County would now appear to be deprived in a great measure of the most appropriate benefits of the (Motor) Road Fund. That the Council have, during the past two years, increased their ex-penditure on County Roads unaided by Grants, by approximately £13,000 and propose to increase this by approximately £5,000 in the coming year, and submit that these facts be considered as showing their bona-fides in the matter.

"As particular examples of the inadequacy of the present Classification there may be quoted the G.S.R. Bus Time Table showing the Route Dublin-Kilcormac, Service No. 28 traversing 11 miles of County Roads, and also three other Services, namely Nos. 9, 21 and 24, showing buses travelling for five miles to the Curragh Camp (which itself is not located on a road declared to be a Main Road). These circumstances would tend to the alternative of the Council considering what legal power they may have to abolish such traffic.

"The Council therefore earnestly request the Minister to consider favourably some system of allocation (whether by re-classification, or altered system of percentage grant) which will enable the Council to receive a sum not less than they received in the (3 years average (1933-36). In asking this, they would respectfully refer again to the figures already placed before the Minister by the County Councils' General Council and would point out that not only do funds of the County suffer by the amount of the reduced Grant for Main road work should a relatively larger sum be allocated to the Secondary Roads, but that this means less employment and added distress in the County, and a larger call on Board of Health Funds for the consequent relief."

Re: Canal Banks at Allenwood, Killina, Etc. Dear Sir.—

In reply to your letter of the 29th ulto, the draft Memorandum to which you refer having very carefully considered by my Board, the conclusion arrived at was, that no useful purpose would be served by adopting the suggestion of a joint deputation to the Minister.

It is stated in the Memorandum that your clients desire that the Canal Company should dedicate to them the trackways referred to "in perpeutity so as to constitute them public roads on which public moneys could be lawfully expended by the Council." And further that the trackways be dedicated to them "free of any conditions save such as apply to any ordinary road." Finally it is stated that your clients "would object to indemnifying the Canal Company against any loss or damage which might accrue from injury to the embankments or retaining walls or other works" of the Company "whereby flooding or other damage might arise."

You will appreciate that the chief concern of The Canal Company is to maintain the Canal and its banks and trackways in such a state that neither navigation or traffic along the Canal shall be impeded.

That bogland is the prevailing character of the country in the County Kildare through which the Canal passes cannot be overlooked and consequently the trackways and banks are unsuitable for conversion into public roads to accommodate modern traffic. The maintenance of the Canal banks and trackways along the section of the Canal in question is a matter of deep concern to The Canal Company and serious breaches in the banks may at any time occur unless extreme care is taken to ensure that the foundations of the trackways and banks and bed of the Canal are not injured or shaken.

My Company's Engineer has carried out an inspection of the sections of the Canal banks and trackways referred to and in his opinion they are entirely unsuited to motor or other heavy traffic, and if such treaffic be permitted there is no doubt that serious breaches in the Canal will occur with extensive damage to and flooding of the surrounding countryside. You and your clients will appreciate that The Canal Company cannot, therefore, agree to a proposal which they are advised might involve heavy additional

Liability was accordingly repudiated.

In connection with above, I would be grateful for your observations regarding the fixing and enforcement of a speed limit for mechanically propelled vehicles in the town of Kildare, in so far as the main Dublin-Cork trunk road is concerned.

The road at Claregate Street, as the Southern End of the town is very narrow, having regard to the volume of traffic, and over this Section especially, it is thought that for the greater safety of all road users the speed of vehicles should be fixed.

I have been talking to Mr. Bergin, the locad Deputy Surveyor, and my impression is that having regard to the potential danger to road users, unless care is exercised in the matter of speed particularly—he too would favour a speed limit.

I think that in the fixing of a speed limit, the siteuation would be suitably dealt with if it covered the road between main entrance to Kildare Artillery Barracks, and 200 yards South of Crosskeys Cross.

Thanking you in anticipation, Section 48 of the Road Traffic Act, 1933, would seem to indicate the concern of your Council in the matter mentioned.

> Emily Square, Athy. 20th Fobruary 1939.

Doar Sir:-

I duly received your letter of the 11th instant and note that the total rates for the last 3 years exclusive of arroars amount to £128.6.8.

I have been carefully considering the position as it is difficult to know what is the best course to adopt. In your provious lotter you stated that the Board of Health wore acquiring some cottages and it occurred to me that we should try to secure this money and for this purpose, I had in mind to obtain a Judgment in the High Court and then apply to have a Receiver appointed over this money.

However, a further difficulty occursto me and that is that the lands may be mortgaged to the Bank or some other person and that there may be land annuities due and if this is so, our Judgmont would be liable to be defeated owing to the fact

of the annuities being due and the Mortgage. Before taking these proceedings, I would like to get in touch with the Land Commission and also to ascortain if, in fact there are any mortgages.

However, all this including the proceedings would mean some considerable expense for which I would have to charge you porsonally. I would, therefore, suggest that you see Mr.Coffey and discuss the matter with him and he might put the matter before the Department of Local Government and ascertain if they would be satisfied that the Council should instruct me in those proceedings, in which event , the Council would be responsible for any costs.

I understand the Ministor's view is that Proceedings for Poor Rates should only be undertaken by the Council in cases of special difficulty and in all other cases that the Rate Collector must themselves take whatever proceedings are nocossary.
