I beg to inform you that the Standing Committee at its recent meeting, had under consideration an application for registration as a matriculated student from Miss Sheila Swift, who, I understand, has been awarded a University Scholarship by your County Council.

Miss Swift has satisfied the University in respect of the subjects, Irish, English, Mathematics, History, Geography, Commerce and Physiology and Hygiene, but having obtained only 10 per cent. in Latin, is not eligible to be registered as a matriculated student.

I enclose pamphlet, from which you will see that no student may begin his course of study leading to a Degree in any Faculty until he has completed his matriculation in such Faculty by satisfying in subjects as fol-

(1) Irish. (2) English. (3) Mathematics. (4) (for Arts, Philosophy, or Celtic Studies), Latin or Greek; (for Law and Medicine, including Dentistry), Latin; (for any other Faculty), Latin or a Modern Continental Language. (5) Any other subject of the Matriculation Programme not already selected.

The Standing Committee decided, before coming to a decision on Miss Swift's application, that I should communicate with you to ascertain whether your Council is in favour of the application being complied with.
