# £250,000 RELIEF VOTE.

The following letter was read from the Department of Local Government and Public Health:—

Rate For 1932-33. Vote of £250,000 Towards Relief of Rates

of Agricultural Land.

A Chara,—Further to my circular of the 21st instant I am directed by the Minister for Local Government and Public Health to explain that the intention of the Government is that the new Grant should be allocated between counties, including those urban districts (if any) already entitled to a share in the original Agricultural Grant on the basis of the total valuation of small farms in separate occupation valued at or under £10 together with £10 per larger agricultural land holding.

For the purpose of apportionment therefore it would suffice if, instead of submitting the detailed lists of holdings under £10 valuation (including of course the valuations) already asked for, a certified statement were prepared and furnished showing

(a) The total valuation of all small farms valued at or under £10, excluding cases where two or more farms are in the same occupation with total valuations exceeding £10, and

(b) The total number of farms exceeding £10 in valuation, reckoning as a unit each case of multiple holdings where the total land valuations exceed £10.

It will, however, be desirable for Rating Authorities, to whom the Grant will be paid, to make such arrangements at this stage as will enable them in due course to issue readily to the individual ratepayers concerned the appropriate credit.

The plots of land attached to labourers' cottages should be included under heading (a) if the entire land held is eligible under the valuation limit even though the Grant will be payable by way of credit to the Boards of Health. It is not, however, intended that share in the Grant should be afforded to the occupiers of land such as small gardens attached and clearly ancil-

lary to dwelling houses. It will be left to Rating Authorities to exclude such cases at their discretion.

I am directed by the Minister for Local Government and Public Health to direct your attention to sub-section (1) of section 5 of the Local Authorities (Officers and Employees) Act, 1926, under which local authorities are empowered, subject to the sanction of the appropriate Minister, to appoint to offices or employments to which that Act applies, certain pensionable or pensioned officers from the Local Appointments Commissioners under the other provisions of the Act.

In reference thereto I am to state that the meaning of the sub-section referred to has recently been considered by the High Court in the case of the Minister for Local Government and Public Health v. the Cork Mental Hospital Joint Committee which has decided that a local authority before proceeding to make an appointment under the sub-section must obtain the prior sanction of the appropriate Minister and that a local authority has no power to make such an appointment unless and until such sanction has been obtained

I am accordingly to state that where a case occurs in which a local authority desire to make an appointment under the sub-section they should as soon as may be after the vacancy in the particular office arises notify the appropriate Minister of their intention to make formal application for the sanction of such Minister before proceeding to make any appointment thereunder. In no case should a local authority purport to make an appointment under the sub-section unless and until

they have received the sanction of the appropriate Minister to their doing so.

I am at the same time to point out that appointments under the sub-section referred to must be made within three months after the occurrence of the vacancy and that accordingly prompt application for sanction should be made in any case where a local authority wish to proceed thereunder in order that delay may be avoided in the filling of vacancies.

I am to add that the appropriate Minister in regard to offices under a Vocational Education Committee or School Attendance Committees is the Minister for Education, in regard to offices under a Committee of Agriculture, the Minister for Agriculture, and in regard to other offices generally the Minister for Local Government and Public Health.



I am directed by the Minister for Local Government and Public Health to advert to the interview granted on the 17th April last by the Parliamentary Secretary, Dr. F. C. Ward, to a deputation from the Kildare County Council in regard to the proposed promotion of Dr. William MacCarthy to the position of County Medical Officer of Health for Kildare County, and I am to state that, as intimated by Dr. Ward, the Minister is prepared to recognise the exercise by local authorities, subject to his sanction, of the powers conferred on them under Section 5 (1) of the Local Authorities (Officers and Employees) Act, 1926, in regard to the appointment of certain pensionable or pensioned officers to offices to which that Act applies.

As regards the application of that procedure, however, to the filling of the vacancy for County Medical Officer of Health for Kildare, the Minister regrets that the recent judicial decision in the case of the late Minister versus the Cork Mental Hospital Joint Committee has laid it down that a local authority before proceeding to make an appointment under the above-mentioned subsection of the Act of 1926 must obtain the prior sanction of the appropriate Minister and that a local authority has no power to make such an appointment unless and until such sanction has been obtained.

It is regretted that in view of this decision the appointment of Dr. William MacCarthy as County Medical Officer of Health intended to be made by the County Council at their meeting on the 23rd November last is not effective, and as the time limit of three months fixed for the operation of the powers under Section 5 (1) of the Act of 1926 has already expired it is not possible now for the Council to avail now of these powers.

It only remains, therefore, for the Council to make application to the Local Appointments Commissioners for recommendations in respect of the filling of the vacancy for County Medical Officer of Health, and in that connection it may be pointed out that the Minister has already sanctioned the remuneration for the office in his letter of the 28th November, 1931.

A form of statutory request in regard to this appointment is enclosed for use by the County Council, and I am to direct attention to the reference therein to the power of the Council to request the Local Appointments Commissioners to recommend to them the names of one, two or three candidates for the position.

I have the honour to report that at the Quarterly Finance Meeting, recently held, Contractors' Applications for payments amounted to £1,619 4s. 7d. The manner in which this sum was dealt with is shown in the following table:—

# Comhairle Congdae Chille Daru.

As will be seen by Contractors' Payments, they have carried out their duties in a normal way.

Good progress has been made in the road improvements being carried out under the usual Road Fund
Grants. About two miles of the main road Monasterevan to Rathangan have been concreted, and as this
has always been a very soft and often muddy thoroughfare, the new surface should give great satisfaction
to the public and those resident alongside. In addition, resurfacing is proceeding between Naas and Ballymore and at Allenwood, and is about to commence at Kilmeague.

Tar spraying has been proceeding satisfactorily in all road sections in the County, and special endeavours to evolve a non-slippery surface appears to have met with success between Dublin and Monasterevan, and to have pointed the way for future work. One unsuitable consignment of tar has been received at Kildare, but I believe it will be possible to obtain satisfaction from the suppliers.

In the present year, perhaps more than ever before, the attention of your road staff has been largely directed to the organisation of the relief of unemployment under the arrangements provided by the Council themselves as well as under Grants given by Government for the same purpose. The Council's scheme of last November whereby work was given in preparing road materials in anticipation of the ensuing financial year has been quite satisfactory, and was the means of expediting tar spraying at a suitable period of the year, and also Road Fund improvement work as soon as the grant became available (and possibly this procedure ought to become a normal one every year especially because the anticipation mentioned results in an earlier disbursement of our road account than heretofore, with a possibility of leaving us short towards the end of the year). The Government Grant of £1,500 given about Christmas last has now been exhausted, and resulted in a large number of works of great importance throughout the County, such as drainage of road hollows, easing bad bends, resurfacing, &c., &c.; and the present grant has been commenced by the preparation of materials for works to be completed under further instalments. In these we work according to the rules of the Departments of Local Government and of Industry and Commerce, which require considerable study and attention. If the necessity continues to other years of such relief, it might be advantageous if all Government grants for road work for the year were united with the Council's road budget for the better organization of complete and continuous schemes of improvement and of the labour to be engaged.

The river-maintenance work in the various arterial drainage districts has been commenced and is proceeding.

# FLOODING IN NAAS.

The following report was read from Mr. Rorke, County Surveyor, and Mr. Sargent. Surveyor to Naas Urban Council:—

Report On Flooding In Naas.
As investigations are still proceeding this can only be regarded as an interim report.

The lower reach of the system of drains has been largely dealt with by the Urban Council, but the sluice gates at outfull are still narrow in comparison to the width of river passing through.

An addition to the dwelling house of Miss Coffey, Sallins Road, has been built for some years over the main river and the new foundations reduces the waterway very considerably. Permission to build this structure has not, so far, been traced.

The Mill Race (main river) between Millbrook and the Main Street, flowing through private grounds, is in a badly neglected condition and probably causes flooding to house property in Poplar Square by overflowing before it enters the tunnel passing under Main Street. It is unlikely that the County Council (apart from the Urban Council) has power to compel the riparian owners to clean

the river in this case.

In order to accommodate floods in peak rainfall and sudden cloudbursts, thunderstorms, etc.,, the Friary Road drain might be duplicated; if the suggested new drain is taken as far as possible through the Rectory Field as an open drain which we consider cheaper than keeping it under public road the whole way the cost would amount to £2,000 approximately. (A length of 200 yards would be reinforced concrete tunnel under public thoroughfares).

Owing to the rapid rate of the deposition of silt, we consider the whole system would require regular and frequent maintenance, which should be carried out at any time simultaneously, as if by one Executive Body.

We are of opinion that a certain quantity of water at present coming into Naas, principally from a stream near Killashee, could readily, and should, be prevented from so reaching the town.

# COUNTY SURVEYOR'S REPORT

The County Surveyor's Report as follows

Mr. Chairman and Gentlemen,-

I have the honour to report that at the Quarterly Finance Meeting, recently held, Contractors' Applications for payments amounted to £1,673 9s. 4d. The manner in which this sum was dealt with is shown in the following table:—

£1,534 13s. 11d. During the Quarter ended 30th September, 1932, in addition to £1534 13s. 11d. recommended for payment as we the sum of 691 999 0. 2d the sum of 69 above the sum of £21,808 9s. 8d. was certified to the Finance Committee as follows:—Main Road, £8,675 6s. 5d.;

With regard to the Grant of £17,900 for Relief of Unemployment the expenditure to 12th November was £9,439 for the whole County. The period laid down for the expenditure of the total grant was something over six months, assuming a commencement in September; and the L.G. Department directed as regards the rate of expenditure that regard should be had for provision at the time when unemployment might be expected to be most severe. In the correspondence which en sued I took it upon myself to make a plea for an increase of the grant if this were possible; and as there are still four months to go before the 31st March it will be seen that the rate of expenditure has been somewhat higher than perhaps has been intended—caused by the heavy lists of unemployed persons in the Unemployment Exchanges to be dealt with. This is to some extent set off by the more recent announcements to Urban Councils of grants to their particular areas, which had however already benefited like other parts of the County under the original allocations.

While the rate of expenditure referred to indicates an earlier completion of the works than the 31st March next as This is the difficulty of procuring a sufficient number of steam rollers to deal with all the road macadam provided within the time limit. We have eight rollers working for some considerable time, two of which I have had to hire from private owners; but I estimate for the work in hand that three more, or possibly four rollers will be required in addition, and I have twice advertised in the Press for tenders
