

#### SECONDARY SCHOLARSHIP SCHEME.

The Committee proceeded to consider Scholarship Scheme for the year 1930. After due consideration the Committee recommended the following Scheme for adoption:--

1—Subject to the sanction of the Department of Education, the Kildare County Council offer ten scholarships, tenable for four years, for competition amongst children not more than 14 years of age on 1st August, 1930, whose parents or guardians have been resident in Co. Kildare for the three years immediately preceding that date and who continue to reside therein during the full term of the Scholarship.

2-Boys and Girls (hereafter called applicants) of promising ability and good character, who have not pregood character, who have school, viously attended a Secondary School, means or that of whose own means, or that their parents or guardians, or other persons responsible for their maintenance, are, in the opinion of the County Council (after considering evidence of same) insufficient to provide them with a secondary education (except as hereinafter excluded by this Scheme) may, under the terms of this Scheme, apply to the Council for Scholarships which, subject to the terms of Clause 4 (b), will be awarded in the order of merit in which said applicants stand in the results of a special examination to be conducted by a body of Examiners approved by the Department of Education to be held in the month of June or whatever time that may be fixed by that Department. 3—Children of parents in receipt of a

3—Children of parents in receipt of a salary or income of over £250, or whose Poor Law Valuation exceeds £25, or in case of parents who derive their living solely from Agriculture a Poor Law Valuation exceeding £100, are not eligible to compete for Scholarships.

4---(a) The value of the Scholarship shall be between the limits of  $\pounds 20$  and  $\pounds 50$ ;  $\pounds 20$  to day Scholars and  $\pounds 50$  to resident Scholars. Any child residing within four miles of a Secondary School to be considered a day Scholar.

(b) In order to avoid an undue preponderance of Scholarships being awarded to pupils in the larger centres of population four of the Scholarships shall be allocated to pupils of Athy, Kildare, Naas and Newbridge Schools, but not more than two Scholarships to any one school, and the remaining Six Scholarships being open to pupils of other approved Primary Schools in the County.

(c) The Primary School from which the pupil comes and the Secondary School to which he or she desires to go, must satisfy the Co. Council and Pepartment of Education that due time and zeal are devoted to the teaching of Irish and Irish History.

5—The evidence of ability, character and means shall be testified on the following Forms prescribed by the County Council, and obtainable from the Secretary.

FORM A.—Application, with statutory declaration at foot, to be made by parent or guardian, or other person responsible for the applicant's maintenance that neither the applicant nor the person responsible for the applicant's maintenance has sufficient means to provide said applicant with a secondary education.

FORM B.—Certificate from the manager of the school where the applicant received his or her primary education that the applicant is of unblemished character and has, by his or her application and ability, shown himself or herself likely to give a satisfactory return for a secondary education.

FORM C.—Certificate from a clergyman of the applicant's parish in support of the evidence given on Forms A. and B., aforesaid.

2-Boys and Girls (hereafter called applicants) of promising ability and good character, who have not pre-viously attended a Secondary School,

that whose own means, or guardians, their parents or other persons responsible for their maintenance, are, in the opinion of the County Council (after considering evidence of same) insufficient to provide them with a secondary education (except as hereinafter excluded by this Scheme) may, under the terms of this Scheme, apply to the Council for Scholarships which, subject to the terms of Clause 4 (b), will be awarded in the order of merit in which said applicants stand in the results of applicants stand in the results of special examination to be conducted by a body of Examiners approved by the Department of Education to be held in the month of June or whatever time that may be fixed by that Department. 3-Children of parents in receipt of a

salary or income of over £250, or whose Poor Law Valuation exceeds £25, or in case of parents who derive their living solely from Agriculture a Poor Law Valuation exceeding £100, are not cligible to compete for Scholarships.

4-(a) The value of the Scholarship shall be between the limits of £20 and £50; £20 to day Scholars and £50 to Any child residing resident Scholars. within four miles of a Secondary School to be considered a day Scholar.

- (b) In order to avoid an undue preponderance of Scholarships being awarded to pupils in the larger centres of population four of the Scholarships shall be allocated to pupils of Athy, Kildare, Naas and Newbridge Schools, but not more than two Scholarships to any one school, and the remaining Six Scholarships being open to pupils of other approved Primary Schools in the County.
  - (c) The Primary School from which the pupil comes and the Secondary School to which he or she desires to go, must satisfy the Co. Council and Department of Education that due time and zeal are devoted to the teaching of Irish and Irish History

Said Forms duly filled in to be lodged with the Secretary of the County Council on or before 15th April, 1930, due notice of which will appear in the Local Press. The County Council shall consider said application and evidence, also any other evidence pertaining thereto.

The County Council shall decide by resolution what applicants comply with the conditions as to character, application, ability, residence and means herein mentioned. The Secretary shall, as soon as may be thereafter, notify the decision of the County Couacil to the applicants, or their parents or guardians, from whom he has received applications on Form A., as aforesaid, and shall notify to those whom the Council decided on as having complied with the said conditions, that cards of admission to the examination (to be held on a date to be fixed, which will not be earlier than June 1st or later than July 1st) shall be forwarded to them from the County Council. An applicant in respect of whom a card of admission, as aforesaid, has been issued will thenceforth be described as a candidate.

6—The following shall be the subjects of examination:—(a), Irish; (b), Engtish; (c), Arithmetic; (d), History and Geography; (e), Algebra; (f), Geometry; (g), Drawing; (h), Rural Science or Nature Study; (k), Needlework.

Candidates must answer in the first four of these subjects, and in any two, but not more than two of the remaining subjects.

To be eligible for the award of Scholarship, a candidate must secure (a) not less than 30 per cent. in each of the essential subjects—(a), Irish; (b), English; (c), Arithmetic; (d), History and Geography, and not less than 50 per cent. of the aggregate marks assigned to these subejcts, and

(b)—Not less than 40 per cent, of the aggregate marks assigned to Irish and English.

(c)-40 per cent. of the aggregate of the maxima in two of the subjects: Algebra, Geometry, Drawing, Rural Science or Nature Study and Needlework; and not less than 20 per cent. in each of the subjects selected.

6—Candidates at the examination may answer in either Irish or English in Arithmetic, History and Geography, Algebra, Geometry, Drawing, Rural Science or Nature Study and Needlework, and that excess marks not exceeding 10 per cent. of the marks scored may be awarded to a candidate who answers a paper in these subjects wholly in Irish, except in the case of Mathematics when such excess marks may not exceed 5 per cent.

7—Each student at the end of each Academic Year must renew application for his or her Scholarship accompanied by a report of satisfactory progress and conduct from the School Authority and to the County Council and the Minister of Education is reserved the right of withholding the Scholarship in the second or any succeeding year if report on student is unsatisfactory in the previous year. A Scholar who does not pass with honours the Department's Intermediate Certificate Examination at or before the end of his third year shall not as a rule be eligible for a further renewal of his Scholarship.

8—The County Council shall hold a meeting in the month of August and award the Scholarships, and the right is reserved to the Council to exclude any candidate from competing for a Scholarship, subject to the approval of the Department of Education. Subject to the same authority the decision of the Council on all questions relating to Scholarships shall be conclusive and final.

Both Deputy Colohan and Mr Rorke rerpe sented strongly that the present opportunity for providing an improved bridge and road approach at Monastereyan ought not to be missed. They stated that the road is an important one and that eight motor buses cross the bridge daily. The inconvenience of the present bridge and approach is gener ally admitted.

Our Chairman said that this Board do not wish to place any obstacle in the way of the desired improvement, but on the contrary would be glad to co-operate with your Council in the matter; but that any money assistance from the funds of the Barrow Drainage scheme must necessarily as pointed out in our letters of 14th and 28th March, be limited to the equivalent of what we shall have to expend on securing the old bridge if the new one is not erected. He asked how the necessary funds for the new bridge and road improvement are to be supplied.

Deputy Colohan and Mr. Rorke were of opinion that the Counties of Leix and Offaly would probably contribute and that the Department of Local Government might also contribute.

Our Chairman explained that unfortunately it is not now practicable for us to suspend action long, because it is very important for the economic and effective prosecution of the Barrow Drainage Scheme that a clean cut through the rock barrier at Monasterevan should be made this summer, and this cannot be done with out either strengthening the Pass Bridge or taking it down.

It was finally arranged that your representatives should endeavour to get at once a decision from your Council and from the Department of Local Government such as will make it clear whether the Scheme for a new bridge and road approach will or will not proceed; and that we should suspend operations at the Pass Bridge for a short period in order to await this decision.

We shall accordingly wait till 15th June before commencing work at the Pass Bridge.

For the better information of the Local Government Department, I beg to point out that payment is in respect of cleansing arising from wear of the surfaces of the Main Roads which the County Council would presumably have to do, but leave to the Urban Councils to do instead, in order to avoid duplication, on a limted area of each Urban Pistrict where the Urban Councils as Sanitary Authorities are responsible for scavenging, and where such scavenging is a matter of great importance to them.

Outside these special areas of the Urban districts (which cover the town areas proper), scavenging is not a matter of special importance and the cleaning which the County Council carry out in the ordinary course of maintenance is \generally contudered sufficient.

The Urban area of Naas contains an exceptional amount of land unbuilt upon which is of the case in Athy and the size of the two towns do not greatly differ.

The extent of impervious road surfaces laid down by the County Council which wear from traffic and consequent need of cleaning is inconsiderable, is greater in Naas than in Athy, and in Athy there is more heavy agricultural traffic.

The fillowing is a schedule of the Main Roads in the special areas mentioned, where the Agreement relates under which the Urban Councils carry out all cleansing.

I recommend that the agreement specifically include the cleaning of gullies and grates or surface water drains.



Same Firm for tough rubber compound is 9353- 8- 8. but no reduction is quoted by con--sulting Engineers for the lesser number of points in this system. Assuming a reduction of £50 in this case the 2nd tender would stand at £303- 8- 8.

The Tunder of the Electricity Supply Board is £155-0-0 for the wiring and £155- 6- 5 for the fittings, total £310- 6-5. This is for the larger number of points originally intended and allowing for the same reduction of 4.50 as above the Tender of the Board would stand at £260 approximately.

In comparing these approximate figures we have to bear in mind the following points: -

"Outside these special areas of the Urban Districts (which cover the town areas proper) scavenging is not a matter of special importance, and the cleansing which the County Council carry out in the ordinary course of maintenance is generally conisdered sufficient. "The Urban Area of Naas contains an exceptional amount of land unbuilt upon, which is not the case in Athy, and the size of the two towns do not greatly differ.

"The extent of impervious road surfaces laid down by the County Council where wear from traffic and consequent need of cleaning is inconisderable, is greater in Naas than in Athy, and in Athy there is more heavy agricultural traffic.

"The following is a schedule of the Main Roads in the special area mentioned, where the Agreement relates under which the Urban Councils carry out all cleansing.

"I recommend that the Agreement specifically include the cleaning of gullies and grates or surface water drains."
